Summary:		The 6 <sup>th</sup> September Board meeting agreed to adopt the Complaints Charter, which is supported by all the members of the Board. Also agreed was a public launch of the Charter so Hackney people are made aware of the aspirations the local health and social care bodies are committed to.			
		At the 7 <sup>th</sup> March Board members reviewed Charter and Booklet options and Healthwatch Hackney was asked to finalise with signatory partners.			
		At this meeting the Charter will be formally launched. A photographer will present to record the launch and members are asked to be available for this photo opportunity. The photos of the launch will be available to members' organisations for their own publicity purposes.			
		To support the promotion of the charter each signatory will need to produce a delivery plan how they will tell their patients and service users including the Foundation Trust members about the charter.			
		The charter was created out of a Healthwatch Hackney NHS Community Voice public meeting on 'Complaining Effectively in the NHS' on 31st January 2017, 85 people attended.			
		At the meeting members of the public called for a local patient's charter on the rights of patients regarding the complaints processes, which all services and providers should sign up to and which treats complainants as valuable contributors to quality service delivery.
