# WITNESS STATEMENT OF JOHN PALMER

### INTRODUCTION

- 1. My name is John Palmer and I am the General Manager at The Premises.
- 2. I have six years' experience in the trade, five of which in Hackney Central. I have been general manager at The Premises since October 2021.
- Jon Dalton owns the premises and is DPS. I work closely with him and he regularly attends the premises in his role.
- 4. I am making this statement in relation to the variation application which seeks the following:
- Opening Hours Monday to Wednesday from 1000 hours to 0030 hours, Thursday from 1000 hours to 0100 hours, Friday to Saturday from 1000 hours to 0130 hours, Sunday 1100 hours to 2300 hours (Unchanged) (Currently Monday to Thursday from 1000 hours to 2330 hours, Friday to Saturday from 1000 hours to 0030 hours and Sunday from 1100 hours to 2300 hours).
- Hours permitted for Sale of Alcohol Monday to Wednesday from 1000 hours to 0000 hours,
  Thursday from 1000 hours to 0030 hours, Friday to Saturday from 1000 hours to 0100 hours,
  Sunday 1100 hours to 2230 hours (Unchanged) (Currently Monday to Friday from 1000 hours
  to 2300 hours, Saturday from 1000 hours to 0000 hours and Sunday from 1100 hours to 2230
  hours).
- Hours permitted for recorded music Monday to Wednesday from 1000 hours to 0030 hours,
   Thursday from 1000 hours to 0100 hours, Friday to Saturday from 1000 hours to 0130 hours,

Sunday 1100 hours to 2300 hours (*Currently Monday to Thursday from 1000 hours to 2300 hours, Friday to Saturday from 1000 hours to 0000 hours and Sunday from 1100 hours to 2230 hours*).

Additionally, we are looking to vary the following conditions:

- Condition 39 to be varied so that it reads, "The external area shall be closed to the public at 23:30 hours from Monday to Thursday, 0000 hours from Friday to Saturday and 22:30 hours on Sundays and shall not re-open until the start of trade the following day, with the exception of smokers immediately outside the front of the premises who will not be permitted to take drinks outside after 23:30 hours from Monday to Thursday, 0000 hours from Friday to Saturday and 22:30 hours on Sundays. This currently reads, "The external area shall be closed to the public at 22:00 hours and shall not re-open until the start of trade the following day, with the exception of smokers immediately outside the front of the premises who will not be permitted to take drinks outside after 22:00 hours."
- Condition 40 to be varied so that it reads, "The maximum number of persons (excluding staff)
  allowed in the external area of the premises shall not exceed 84 seated patrons" (Currently
  30 Patrons).
- Condition 41 to be varied so that it reads, "Notices will be displayed in the external area stating that this area is for seated patrons only. Waiter/Waitress services will be available in the external seating area after 17:00 hours on Thursday to Saturday between April 1st and September 30th each year." This currently reads, "The external area will display notices advising customers that the area is for seated patrons only and customers that are not seated will be asked to leave this external area. Service to this area will include on a Thursday, Friday and Saturday night between 17:00 hours until close, which will be by waiter/waitress only between the months of April and September."
- The addition of a condition that states: The requirement for door supervisors shall be risk assessed by the DPS or a nominated staff member. The risk assessment will be documented and will detail the following:
  - a. Hours of operation (start and end)
  - b. Expected customer numbers and peak times for customer attendance
  - c. Any specific risks identified such as local events, particularly hot weather, national holidays etc.
  - d. Number of door supervisors (if any) to be employed and start and finish times.

Where the risk assessment identifies door supervisors are required, they shall be employed in the numbers and at the times identified. A copy of each risk assessment will be retained for a minimum of 12 months and shall be made available to the Metropolitan Police on request.

### **ABOUT THE APPLICANTS**

5. The Hackney Tap forms part of an estate of around 15 premises that includes, amongst other leisure premises, a number of gyoza bars and craft beer bars. These are in London, Bristol and Manchester. They are run to the highest standards and are often found in 'difficult' locations that suffer from homelessness or street drinking, such as major transport hubs. It is fair to say that having well managed premises open and trading in these areas has been considered a benefit in moving on these types of problem and allowing the area to become more welcoming. This is exactly what happened here. These premises operate without trouble and over the past 20 years the operators have built up an excellent track record of serving their communities.

#### ABOUT THE HACKNEY TAP

- 6. Opened in April 2021, the Hackney Tap has been a welcome addition to the Hackney Central area. We have excellent relations with residents in the area, including our immediate neighbours on the Mare Street Narrow Way, many of whom are regular customers. We have never had a noise complaint.
- 7. The last year under this management has seen only one police call-out for a burglary on site, but we have in the past provided the police with our CCTV footage to help with off-site criminal investigations. Any problems we experience with homeless people or drunks are deescalated and resolved quickly, politely and ensuring no adverse consequences.
- Some people use The Premises as part of a general exploration of the area, staying for shorter times and a quick bite to eat or drink and others stay longer- especially people who live and work in the area.
- 9. We attract a mixed crowd of young and older customers, male and female. It has been commented on to me that our female customers witness are sometimes affected by cases of inappropriate behaviour in the parks around the church, but not at the Hackney Tap, including outside.
- 10. Customers often use the outside area because it feels safe and welcoming. Some people still are worried about using indoor spaces- especially those with health issues and we find that regularly we are having to turn away customers due to the limits on the numbers we can have outside.

- 11. Customers enjoy using the the QR codes on tables letting them get served their food and drinks by the staff as it means they are not required to come inside.
- 12. Whilst we do not have data on how much customers drink on average or how long they stay, we have very few issues with customers getting intoxicated at our premises. We serve a number of low and non-alcoholic drinks, including beers, that are popular and I would say that as a rule of thumb customers tend to stay for a maximum of three drinks- although some may stay for more.

### SUMMARY

- This application will allow us to build on our success and continue to grow and serve our
  customers as they would like. The Premises itself is relatively small inside and without the
  additional seating outside, we struggle to serve all of our customers and have to turn people
  away.
- 2. The Premises has been a benefit to the area. Customers who live nearby often tell us about how the area has been improved by our presence and that some of the issues they faced before with anti-social behaviour and intimidation have reduced because of our presence. Allowing people to stay outside later will allow them to benefit from this deterrence from anti-social behaviour later.
- Additional people in the external area will not cause any issues. We already reach capacity
  and manage customers well, which means there have been no complaints about noise
  outside. A small number of badly managed customers causes a lot more issues than a well
  managed larger capacity.
- 4. The changes are all requested to allow the business to develop and grow in very uncertain times, where hospitality premises are facing significant problems with staffing, cost increases and now huge energy bill increases- even with government support. All of this means that we must look at how we can trade effectively to ensure the business remains viable.
- 5. Of course, we understand that we need to promote the licensing objectives, and we will work hard to do so. We will also listen to our neighbours should any of the changes cause them issues- but given our track record of trading, the support from our neighbours and the fact that we have an unblemished track record in operating for 16 months, we believe that these changes will be of benefit for us and the community.

We are aware the venue is looking to extend their license which has been rejected due to the accusation that the pub is a problem for our local area which I can assure you it's not. It's a pleasure to have the pub across the street and it would be a huge disappointment to see this local business not get the support from the council that it deserves. Please find down below a list of more reasons to extend the Hackney Tap's license.

We've never had any issues with noise from this venue. Customers outside who are drinking are talking at normal/ civilised volumes and aren't amplified by loud music. Comparing the noise and ruckus behaviour that comes from around the area there is absolutely no cause for concern regarding noise levels from the Hackney Tap.

We've never had issues of alcohol induced violence or bad behaviour from customers at this pub. The staff are extremely vigilant and professional. They're quick to diffuse any situation and are first to not serve if a customer is acting inappropriately. The pub is a great way for people to sit and have a drink in a safe and secure environment. Over the last year living in the area as young women, we've had more cases of inappropriate behaviour in the parks around the church from people sitting and drinking cans without supervision. To see the pub leave our neighbourhood would indefinitely increase the problems induced by unsupervised drinking particularly in the warmer months.

As you can gather from the above paragraph the venue has never had any police call outs. This reiterates the venues efforts to keep their pub a safe and secure spot for their customers.

On a more positive note this pub is at the hub of our local community. It's our place to relax and grab a quick one. We want to support local business particularly in these tough times and cherish what they do for our community. I don't understand why Hackney Council wouldn't extend their license. All of our neighbours in the building are regulars and have zero complains regarding this local business.
