- 1 Election of Chair
- 1.1 Cllr Smyth was duly elected as Chair of the meeting.
- 2 Apologies for Absence
- 2.1 There were no apologies for absence.

- 3 Declarations of Interest Members to declare as appropriate
- 3.1 There were no declarations of interest.
- 4 Minutes of the Previous Meeting
- 4.1 There were no minutes for consideration.
- 5 Licensing Sub-Committee Hearing Procedure
- 5.1 The hearing procedure was noted by all present.
- 6 Premises Licence Variation Beechwood, Principal Place, 115 Worship Street, EC2A 2BA
- 6.1 The sub-committee heard from the Principal Licensing Officer, Counsel for the applicant and the Licensing Authority. During the course of submissions and a discussion of the application, the sub-committee noted the following:
 - Since the publication of the officer report, the applicant had proposed further conditions to address the concerns expressed.
 - Counsel for the applicant stated that the applicant was seeking to extend the hours on Sunday for the sale of alcohol from 10:00 to 01:00 hours and late night refreshment from 23:00 to 01:30 hours during the months of September to March, the premises was a restaurant and bar that would be exclusively showing sports events, the sale of alcohol would be ancillary to the live screening of events, there would be no entry from 23.00 hours, an additional four conditions had been submitted to address the concerns related to crime and disorder and public nuisance, and no objections had been received from the local residents and Responsible Authorities except the Licensing Authority.
 - The Licensing Authority's representative stated that the premises was located within the Shoreditch Special Policy Area (SPA), the proposed activity would further exacerbate the negative cumulative impact identified in the area as a result of the large concentration of licensed premises, and further clarification was sought regarding the nature of the televised sporting events.
 - Counsel for the applicant clarified that the bar would be broadcasting exclusively NFL American Football live sporting events and college football.
 - In response to questions from the sub-committee, Counsel for the applicant responded that the premises were located within a quiet corner of Shoreditch, an average 30 to 50 patrons were expected at any event which was 50% of the total seating capacity inside the premises, the ambience would be relaxed with games estimated to last approximately 2 to 3 hours, alcohol would be sold ancillary to food, patrons would need to book in advance for an event via a booking system which would allow management to know the numbers expected, a minimum of two SIA door supervisors would be employed to manage dispersal in order to minimise any negative impact on the area, no more than five smokers would be permitted at any one time and no drinks outside, the clientele would include local residents, Amazon was above the premises but it was closed on Sunday, and dispersal from the exit doors leading directly into the City of London would have minimal impact as there were not many residents living in the area.
 - A risk assessment would be undertaken for each event to determine if more than two SIA door supervisors were required.

- The applicant reassured the sub-committee that there would be no vertical drinking at the premises and that alcohol would be served ancillary to food by waiter service or if ordered online. A full kitchen would be open until closing hours and patrons would have the choice of ordering food such as wings, nacho, burgers.
- The applicant and the Licensing Authority's representative agreed to the late night refreshment ceasing at 01.00 hours in line with the hours for the supply of alcohol.

The decision

The Licensing Sub-Committee, in considering this decision from the information presented to them within the report and at the hearing today and having regard to the promotion of the licensing objectives:

- The prevention of crime and disorder
- Public safety
- Prevention of public nuisance
- The protection of children from harm

The amended application to vary a premises licence has been approved in accordance with the Council's Statement of Licensing and the proposed conditions set out in paragraph 8.1 of the report, and the following conditions will be added to the premises licence proposed by the Premises Licence holder, these conditions only apply during the operation of extra hours on Sundays in the months of September to March each year:

- The Sale of alcohol after 2300 shall at all times be ancillary to the screening of a television broadcast of a live sporting event.
- Last entry to the premises will be 23:00 during the months of September to March and ancillary to the screening of a television broadcast of a live sporting event.
- The maximum number of persons permitted outside to smoke shall not exceed 5 persons at any one time. Such persons are not permitted to take drinks outside. The designated smoking area is immediately outside the building at the side entrance alcove on Worship Street.
- At least two SIA licensed door supervisors shall be on duty. The licence holder will also have full regard to its own written risk assessment when considering each event and in determining whether more than two door supervisors are required. That risk assessment to be kept under constant review.

Reasons for the decision

The application to vary this premises licence has been approved, as members of the Licensing Sub-committee were satisfied that the licensing objectives would not be undermined in the Shoreditch Special Policy Area (Shoreditch SPA)

The Sub-committee took into consideration the objection to the application made by the Licensing Authority on the grounds of the prevention of public nuisance in the Shoreditch SPA. The Sub-committee noted that there were no objections from the other Responsible Authorities and there were no objections from local residents.

The Sub-committee took into consideration the representations made by the Licensing Authority, and their concerns about the impact on the Shoreditch SPA which suffered from public nuisance and the cumulative impact in the area. The Sub-committee also took into consideration that the premises is located in the Shoreditch SPA and therefore it is subject to Policy LP10.

The Sub-committee took into account that the Premises Licence holder applied to extend the hours for the sale of alcohol and late night refreshment on Sunday nights into Monday mornings during the months of September to March each year and when "ancillary to the screening of a television broadcast of a live sporting event".

The Sub-committee after hearing from the Applicant and the Licensing Authority were satisfied that the premises would not add to the cumulative impact in the area, and would not threaten the licensing objectives in the Shoreditch SPA. The Sub-committee took into consideration the nature of the business, and that it is a modest size premises. The Sub-committee noted it was a food led premises and food will be available at all times when alcohol is served.

The Sub-committee also took into consideration that the above conditions proposed by the Premises Licence holder, these conditions only apply during the operation of extra hours on Sundays in the months of September to March each year.

Having taken all of the above factors into consideration the Sub-committee was satisfied that by granting this variation of the premises licence, the licensing objectives would continue to be promoted in the Shoreditch SPA.

7 Premises Licence Variation - Blondies, 205a Lower Clapton Road, London, E5 8EG

- 7.1 The sub-committee heard from the Principal Licensing Officer, the applicant and the Other Persons. During the course of submissions and a discussion of the application, the sub-committee noted the following:
 - Since the publication of the officer report, the applicant had submitted additional information.
 - The applicant was a responsible operator and owned the business for seven years.
 - She had successfully run over 100 TENs over 7 years without any complaints or issues.
 - The applicant emphasised that it was a rock and roll venue, a community hub and safe space especially for women and LGBT, it attracted local and international artists and fans, they had successfully gained accreditation of the Hackney Nights Accreditation Scheme, the activities would be controlled to minimise any impact on the area, they had submitted many policies including Noise and Nuisance Management, dispersal, counter terrorism and burns protection, they had held bi-monthly meetings which residents had not attended, the nuisance experienced in the area were not related to her

- premises, 181 people had signed the petition in support of the application and 57 written representations in support had been submitted.
- The applicant responded that the noise management report findings indicated the sound limiter had been effective in controlling the sound levels within the premises and that the traffic noise from the busy road was louder than the noise inside.
- The applicant replied that the drug use in Lower Clapton Road had been an ongoing issue but had gradually improved over the years. The Other person added that the issues of drug use and anti-social behaviour in the area were not related to this premises.
- The Other Persons present expressed their support for the application emphasising that the premises provided a safe space particularly for female and elderly people, the venue was a community hub that had a positive impact on the neighbourhood, it had provided opportunities for young and old artists and technicians, it was a forward thinking bar playing live music, there had been no issues at the premises, they had confidence in the management, it was a great cultural asset for Clapton, the venue had attracted an international clientele and was well publicised on YouTube.
- The Other Person indicated that the evidence submitted and the representation from the applicant had assured him that the premises was well managed, however, he expressed concern that the hours being sought for live music in a residential area especially on a school and working day would cause a public nuisance to local residents and in particular children. Local residents needed assurance from the applicant that the previous issues of nuisance would not recur and scheduling regular residents' would provide reassurance for local residents as they could raise and have their concerns addressed.
- The applicant confirmed that the capacity was 55 persons and that there were posters displayed asking patrons to leave quietly and that dispersal was staggered throughout the evening.
- Music was played below conversation level to prevent a public nuisance and artists/bands understood they were playing in a small soundproofed premises with 10% of the income generated from the alcohol sales given to the artist.
- The noise assessment was undertaken when the premises was hosting a band and DJ to ensure an accurate reading of the sound levels were taken.
- To minimise noise the applicant ceased playing live music at 22.00 hours during weekends, this was earlier than permitted on their licence.
- The applicant held approximately two to five live performances annually but no more than 10. However, since Covid-19 pandemic they had not played any live music.

The Licensing Sub-Committee, in considering this decision from the information presented to them within the report and at the hearing today and having regard to the promotion of the licensing objectives:

- The prevention of crime and disorder
- Public safety
- Prevention of public nuisance
- The protection of children from harm

The amended application to vary a premises licence has been approved to change the layout of the premises in accordance with the Council's Statement of Licensing and the proposed conditions set out in paragraph 8.1 of the report, with the following amendments:

The hours for licensable activities, shall be, as agreed:

Recorded Music:

Monday - Wednesday 23:00 - 23:30 Thursday - Saturday 23:00 - 01:00

Supply of Alcohol (on-sales)

Monday – Wednesday 12:00 - 01:00 Thursday - Saturday 12:00 - 01:00

Opening hours of the premises

Monday – Wednesday 12:00 - 01:30 Thursday - Saturday 12:00 - 01:30

Condition 32 shall be amended as follows:

"The maximum number of smokers permitted at the front of premises at any one time shall not exceed 8 persons".

Condition 35 shall be amended as follows:

"There will be no drinks at the front of the premises after the tables have been taken in at 21:30".

Condition 36 shall be amended as follows:

"There shall be no use of the outside space after 21:30".

Reasons for the decision

The application to vary this premises licence has been approved, as members of the Licensing Sub-committee were satisfied that the licensing objectives would not be undermined.

The Sub-committee took into consideration that the Environmental Protection Team had withdrawn their representations, and agreed conditions with the licence holder in advance of the hearing.

The Sub-committee noted there was only one representation from a local resident against the application on the grounds of the four licensing objectives and 56 representations were received in support.

The Sub-committee noted that the premises are not situated in a Special Policy Area. Also the Premises Licence holder demonstrated that they have listened to concerns

raised and there was a great deal of support from the community, and music industry bands.

The Sub-committee took into consideration that the premises had a good dispersal policy, the noise report was professional, and overall they had good policies and accreditation to operate the premises responsibly. The Sub-committee took into account that the premises had local co-operation and strong support from local residents.

Having taken all of the above factors into consideration the Sub-committee was satisfied that by granting this variation of the premises licence, the licensing objectives would continue to be promoted.

1 Election of Chair

1.1 Cllr Smyth was duly elected as Chair of the meeting.

- 2 Apologies for Absence
- 2.1 There were no apologies for absence.
- 3 Declarations of Interest Members to declare as appropriate
- 3.1 There were no declarations of interest.
- 4 Minutes of the Previous Meeting
- 4.1 There were no minutes for consideration at the meeting.
- 5 Licensing Sub-Committee Hearing Procedure
- 5.1 The meeting participants noted the hearing procedure for the meeting.
- 6 Premises Licence Variation: Faulkners, 424-426 Kingsland Road, E8 4AA
- 6.1 NOTED the additional information including amended and additional proposed conditions circulated prior to the meeting.
- 6.2 Suba Sriramana, Principal Licensing Officer introduced the variation application seeking to extend the hours for the sale of alcohol on and off premises and late night refreshment, and to include the hours for regulated entertainment. Representations were received from the Police, Licensing and Health Authority, and it was reported that there had been an error in the report and that the premises were located within the Dalston Special Policy Area (SPA).
- 6.3 Graham Hopkins, the applicant's agent outlined the application including the additional/revised conditions to address the concerns raised by the responsible authorities including further reducing the extended hours, a condition that alcohol would be sold ancillary to food in the restaurant and take-away/delivery business, the licensable activities play and dance had been removed, 55 to 60 covers inside the premises and 12 seats allowed in the outside area, the outside table and chairs would not be in use from 22.00 hours daily, a dispersal policy, a maximum of 6 smokers at any one time, a sound limiter had been installed, risk assessments would be undertaken daily and condition 9 had been amended to include delivery drivers. The business had been suffering financial losses since Covid-19 and from local competition and the extended hours would enable the business to compete and survive.
- 6.4 In response to questions from members seeking clarification regarding the application, Mr Hopkins confirmed that the applicant had not applied for any TENs and an additional condition had been proposed to address the concern relating to children's safety 'Any unaccompanied children shall not be allowed at the premises after 22.00 hours.'
- 6.5 Channing Riviere, Licensing, objected to the application on the grounds of public nuisance and welcomed the reduction in the extended hours for licensable activities and off sales but emphasised the hours still exceeded the Council's Core Hours, there had been no measures proposed to mitigate the potential rise in public

nuisance arising from motorcycles being used for deliveries during the later hours. It was highlighted that there were no concerns about the applicant's track record.

- 6.6 PC Griggs, Police objected to the application on the grounds of the prevention of crime and disorder and public nuisance. She welcomed the assurance that the premises would operate as a restaurant but concerns remained about the range of the regulated entertainment, the potential increase in public nuisance from the external seating area being open until 22.00 hours and how the dispersal policy would be implemented for the proposed later hours.
- 6.7 In response to questions from members regarding noise nuisance, Mr Hopkins confirmed that the licensable activities play and dance had been removed from the application, live and recorded music would be played until 01.00 hours for the occasional parties held at the venue, live music would be played at background level, live performances would be held after 23.00 hours and up to 15 delivery drivers would be allowed in the designated waiting area for takeaway collections.
- 6.8 George Wokorach, Environmental Protection objected to the application and enquired how the applicant intended to minimise noise nuisance from the proposed live and recorded music to be played inside the premises and the noise from the external area during the later hours, how dispersal would be implemented during the later hours without causing a disturbance to residents, there needed to be a specific end time for takeaway deliveries, a specific number of delivery drivers permitted in the waiting area and restricting the capacity at the premises. It was emphasised that the noise from the premises and the external area combined would create a tunnel effect due and as a result cause more noise nuisance.
- 6.9 In response to the concerns raised, Mr Hopkins proposed that live music could be reduced to 01.00 hours and limited to two acoustic musicians, Uber delivery drivers could be required to wait inside the takeaway and asked to switch off their motorcycle to minimise noise nuisance, and agreed to cease off sales of alcohol at 00.30 hours Monday to Sunday and late night refreshment and on sales of alcohol until 01.30 hours Thursday to Saturdays, and up to 15 people would be allowed in the takeaway waiting area.
- 6.10 The applicant made closing remarks in support of granting the application.

- Remove "Plays" from the premises licence.
- Remove "Anything of a similar description" from the premises licence.

And the following additional conditions:

- The external seating area shall be closed with furniture rendered unusable by 22:00 each day save for a maximum of six (6) smokers after this time.
- There shall be a written dispersal policy submitted to and approved by the Licensing Authority and the Police which shall be reviewed regularly. The approved dispersal policy shall be implemented at the premises by the staff. All staff shall be trained on this dispersal policy. A copy of the policy shall be kept on the premises and shall be produced to a police officer or other authorised officer upon request.
- No bottles, glasses or alcoholic drinks shall be taken outside except for consumption in the external area at the outside tables and chairs until 22:00.
- All amplified music shall be played through a noise limiter set and sealed by an Environmental Protection Officer and the premises Acoustic Consultant.
- All doors and windows shall be closed during the playing of regulated entertainment except for entry and egress.
- External noise patrols shall be undertaken at least every half an hour to ensure music noise cannot be heard at the nearest noise sensitive premises. Details shall be recorded in the Incident Book.
- There shall be a member of staff tasked for the purpose on the door from the terminal hour until at least 30 minutes after the premises closes and all customers have left the premises. They shall ensure that no glasses, bottles or open alcoholic drinks are removed from the premises, remind customers to leave quietly, quickly and ensure that they do not loiter outside the premises.
- The Premises Licence Holder / Designated Premises Licence holder shall ensure that an ongoing daily risk assessment shall be undertaken taking into account any advice received from the Police or events taking place locally, to identify any need for additional staff or SIA Licensed Door Supervisors to be on duty.
- Off sales of alcohol shall only be made to accompany a substantial food order for customer collection or home delivery and be limited to a maximum of 8 bottles or cans or beer, lager or cider and or 2 bottles of wine per order.
- No children shall be permitted on the premises after 20:00.
- Staff shall verbally instruct delivery drivers and riders to turn their engines off while collecting orders. Delivery drivers remain inside the premises when collecting food orders.

Reasons for the decision

The application to vary a premises licence has been approved, because members of the Licensing Sub-committee were satisfied that the licensing objectives would not be undermined.

The Sub-committee took into account that the Responsible Authorities (the Environmental Protection Team, the Licensing Authority and the Metropolitan Police Service ("the Police") raised objections to the application. The Environmental Protection Team, and the Licensing Authority objected to the application on the grounds of public nuisance. The Police objected to the application on the grounds of public nuisance and crime and disorder. The Sub-committee noted no other Responsible Authorities and no local residents objected to the application.

The Sub-committee took into consideration the representations made by the Police and their concerns about the impact that the increased hours would have on the Dalston Special Policy Area (Dalston SPA) and the cumulative impact on the area. The Sub-committee noted that the Applicant took on board the advice from the Police and the Licensing Authority and revised their hours and conditions to be more suitable for the Dalston SPA. The Sub-committee took into consideration that alcohol will be ancillary to food.

The Sub-committee heard the representations made by the Applicant's representative that the premises is a fish and chip restaurant which has been open for the last 20 years. The Sub-committee noted that the Applicant was seeking the variation of the premises licence to improve the business. The Sub-committee took into account that the existing premises licence has a restaurant condition that alcohol cannot be supplied on the premises without a substantial table meal being served which will remain on the licence. The Sub-committee noted that the takeaway meals are delivered by electric bikes and motorcycles and events at the weekend are usually birthdays or similar celebrations.

After hearing representations from the Applicant and the Responsible Authorities (the Environmental Protection Team, the Licensing Authority and the Metropolitan Police Service) the Sub-committee felt that the variation should be granted because the Applicant offered reduced hours which helped to alleviate their concerns. The Sub-committee took into consideration that the premises is situated on the boundary of the Dalston Special Policy Area and may add to the cumulative impact in the area.

The Sub-committee felt that with the conditions offered by the Applicant including a dispersal policy together with the reduced hours it would mitigate the concerns and impact on the area. The Sub-committee took into account that the Police and the Licensing Authority agreed to the conditions. The Sub-committee felt that the Applicant demonstrated that they are an experienced operator with a good track record who could operate the premises responsibly.

The Sub-committee took into account that the Applicant agreed that there will be a cut-off time for the number of deliveries. Drivers on electric bikes will be inside. The deliveries by electric bikes will turn off their engine and the food order will be collected inside to mitigate the noise and music will be regulated through a noise limiter. The Sub-committee noted that the premises will remain as a restaurant, and it was agreed off-sales of alcohol will end at 00:30 Thursday to Saturday.

The Sub-committee took into consideration that the Licensing Authority accepted the reduced hours, the conditions and that the premises will remain as a restaurant predominantly. The Licensing Authority were also satisfied that the takeaway hours were being reduced by one hour and that alcohol will be served ancillary to food.

The Sub-committee heard that the Police had no reason to visit the premises and they were aware that the Applicant has held the licence for this restaurant for the last 20 years. The Sub-committee took into account that the Applicant agreed to the outside seating area being closed at 22:00. The Sub-committee took into account that the Police had concerns, however, they had been allayed following the representations made by the Applicant.

The Sub-committee cannot determine the application based on economic factors. Each application is determined on its own merits.

Annex 1 - Mandatory Conditions

Supply of Alcohol(On/Both)

- 1. No supply of alcohol may be made under the premises licence:
 - (a) At a time when there is no designated premises supervisor in respect of the premises licence.
 - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 4. dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on

request to customers where it is reasonably available.

- 6. 5.1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sales or supply of alcohol.
 - 5.2 The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - 5.3. The policy must require individuals who appear to the responsible person to be under 18 years if age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
 - A. a holographic mark or
 - B. an ultraviolet feature.
- 7. The responsible person shall ensure that:
 - a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
 - beer or cider: 1/2 pint;
 - gin, rum, vodka or whisky: 25ml or 35ml; and
 - still wine in a glass: 125ml; and
 - a. these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - b. where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

- 7.1 A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 7.2 For the purposes of the condition set out in paragraph 7.1 above -
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979:
- (b) "permitted price" is the price found by applying the formula P = D+(DxV) Where -
- (i)P is the permitted price,
- (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (c) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (d) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

- (e) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (f) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 7.3 Where the permitted price given by Paragraph 8.2(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 7.4 (1) Sub-paragraph 7.4(2) below applies where the permitted price given by Paragraph 7.2(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Door Supervision

8. Each individual who is to carry out a security activity at the premises must be licensed by the Security Industry Authority.

Annex 2 - Conditions consistent with the Operating Schedule

- 9. The premises shall maintain a comprehensive CCTV system as per the minimum requirements of the Metropolitan Police Crime Prevention Officer. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or any authorised officer of Hackney Borough Council. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times -when the premises are open to the public. This staff member shall be able to show Police or any authorised officer of Hackney Borough Council recent data or footage with the absolute minimum of delay when requested.
- 10. An incident log shall be kept at the premises, and made available immediately on request to any authorised officer of the Hackney Borough Council or the Police, which will record the following:
 - a. all crimes reported to the venue;
 - b. any complaints received;
 - c. any incidents of disorder;
 - d. any faults in the CCTV system or searching equipment or scanning equipment;
 - e. any refusal of the sale of alcohol;
 - f. any visit by a relevant authority or emergency service.
- 11. There shall be "CCTV in Operation" signs prominently displayed.
- 12. All instances of crime or disorder are to be reported by the Designated Premises Supervisor or a responsible member of staff to an agreed police contact point, as agreed with the Police.
- 13. There shall be no promotional sales of alcohol at the premises.
- 14. There shall be a minimum of 4 SIA registered door supervisors employed at the public house and restaurant on a Thursday, Friday and Saturday evenings from 2000 hours to 30 minutes after closing on these days. Additional SIA registered door supervisors to be employed on an operational risk assessment basis. All door supervisors shall enter their full details in the premises daily register at the commencement of their work. They shall record their full name, home address and contact telephone number, their SIA registration number, and the time they commence and conclude working. If the door supervisor was provided by an agency the name, registered business address and contact telephone number will also be recorded. This register will be made available to police or any authorised officer of Hackney Borough Council immediately upon request.
- 15. There shall be no glass, drinks or open containers outside the front of the premises at any time. Customers shall not be permitted to take glasses, drinks or open containers outside the front of the premises at any time, with the exception of water in plastic vessels.

- 16. Entry and exit to the premises shall be through the front main entrance directly into the premises and not the access way between the restaurant at 163 Mare Street and the Dolphin Bar at 165 Mare Street, except after 0000hours Sunday to Thursday
- 17. Where the sale or supply of alcohol is taking place, employees of the premises must request sight of evidence of the age of any person appearing to be under 25 years of age (Challenge 25). Such evidence may include a driving licence or passport.
- 18. The premises will also, in cooperation with the police, regularly facilitate a premises drug audit using the ion itemiser or similar device
- 19. The premises will display prominent signage by every entrance and exit, requesting customers to leave the premises quietly and respect local residents.
- 20. The premises will display and maintain appropriate signage advising customers of the contact details, including telephone contact numbers, of the Designated Premises Supervisor and the manager of the premises.
- 21. Refuse, including bottles, shall not be taken outside the premises between the hours of 2000 and 0800.
- 22. All staff should receive training and have an awareness of the four licensing objectives.
- 23. All emergency exits will remain clearly marked at all times. Emergency escape routes will be kept free of obstruction at all times.
- 24. The Licensee shall ensure that all staff are fully trained and made aware of the legal requirement of businesses to comply with their duty of care as regards the disposal of waste produced from the business premises. The procedure for handling and preparing for disposal of the waste shall be in writing and displayed in a prominent place where it can be referred to at all times by staff.
- 25. The Licensee shall ensure that any contract for general and recyclable waste disposal shall be appropriate in size to the amount of waste produced by the business.
- 26. The licensee shall maintain an adequate supply of waste receptacles provided by his registered waste carrier (refuse sacks or commercial waste bins) in order to ensure all refuse emanating from the business is always presented for collection by his waste carrier and shall not use unidentifiable refuse sacks or any other unidentifiable or unmarked waste receptacles
- 27. In order to minimise the amount of time any waste remains on the public highway in readiness for collection, the Licensee will ensure the timeframe within which it may expect its waste carrier to collect is adhered to.
- 28. The Licensee shall erect a sign asking customers to refrain from littering the public highway outside the premises and will also instruct a member of staff to make regular checks of the area immediately outside and within 10 metres either

- side of the premises and remove any litter, bottles and glasses emanating from the premises. A final check should be made at close of business.
- 29. The Licensee shall provide a safe receptacle for cigarette ends to be placed outside for the use of customers, such receptacle being carefully placed so as not to cause an obstruction or trip.
- 30. The Licensee's premises are situated in an area within which refuse may only be left on the public highway at certain times (time bands). If the Licensee's waste carrier cannot or does not comply by collecting the refuse within an hour after the close of any time band imposed by the waste authority, the Licensee must remove the refuse from the public highway and/or keep it within the premises until such time as his/her waste carrier arrives to collect the refuse.
- 31. All devices capable of playing music in either premises shall be operated through a sound limiting device. The sound limiting device shall be installed within the premises and set at a level determined by and to the satisfaction of an authorised officer of the Noise Pollution Service to allow no more than background music after 2330 hours. The operational panel of the noise limiter shall be secured to the satisfaction of the officer. The keys securing the device shall be held by the Designated Premises Supervisor or another responsible member of staff, and the device shall not be accessed via any other person. The limiter shall not be altered without prior agreement with the Noise Pollution Service
- 32. The premises will operate an electronic identification scanning system (e.g. ClubScan) after 2100 hrs for customers entering the premises.
- 33. Door staff shall use "clickers" to monitor capacity at the premises.
- 34. A free cloakroom service shall be provided, and suitable signage displayed encouraging customers to use it.

Annex 3 – Conditions attached after a hearing by the licensing authority (After the expedited/summary review hearing on 29/11/2022)

- 35. All staff engaged in the sale of alcohol shall be fully trained and made aware of the legal requirements relating to underage sales and other legal requirements relating to the sale and supply of alcohol. Such training must take place on a 12 monthly basis and written records of the training must be maintained on the premises for inspection by the Police or Authorities. This training is to include WAVE (Welfare And Vulnerability Engagement) training.
- 36. All staff will be given refresher training every six months on the legislation relating to the sales of alcohol to underage persons and drunken persons. Written records of this training shall be kept on the premises and produced to police or other authorised officers upon request.
- 37. A written Dispersal Policy shall be submitted to and approved by the Licensing Authority and the Police, and a copy shall be kept on the premises and made available to the Police or other authorised officers upon request.
- 38. No live or recorded Music to be played in the garden.
- 39. The premises licence holder shall provide the Licensing Authority with a copy of their Risk Assessment.
- 40. The premises licence holder shall provide a new plan for the garden.
- 41. The capacity of the premises shall be agreed with the Licensing Authority.
- 42. On Thursday to Saturday, the search policy will also apply when any private events that are held at the premises.
