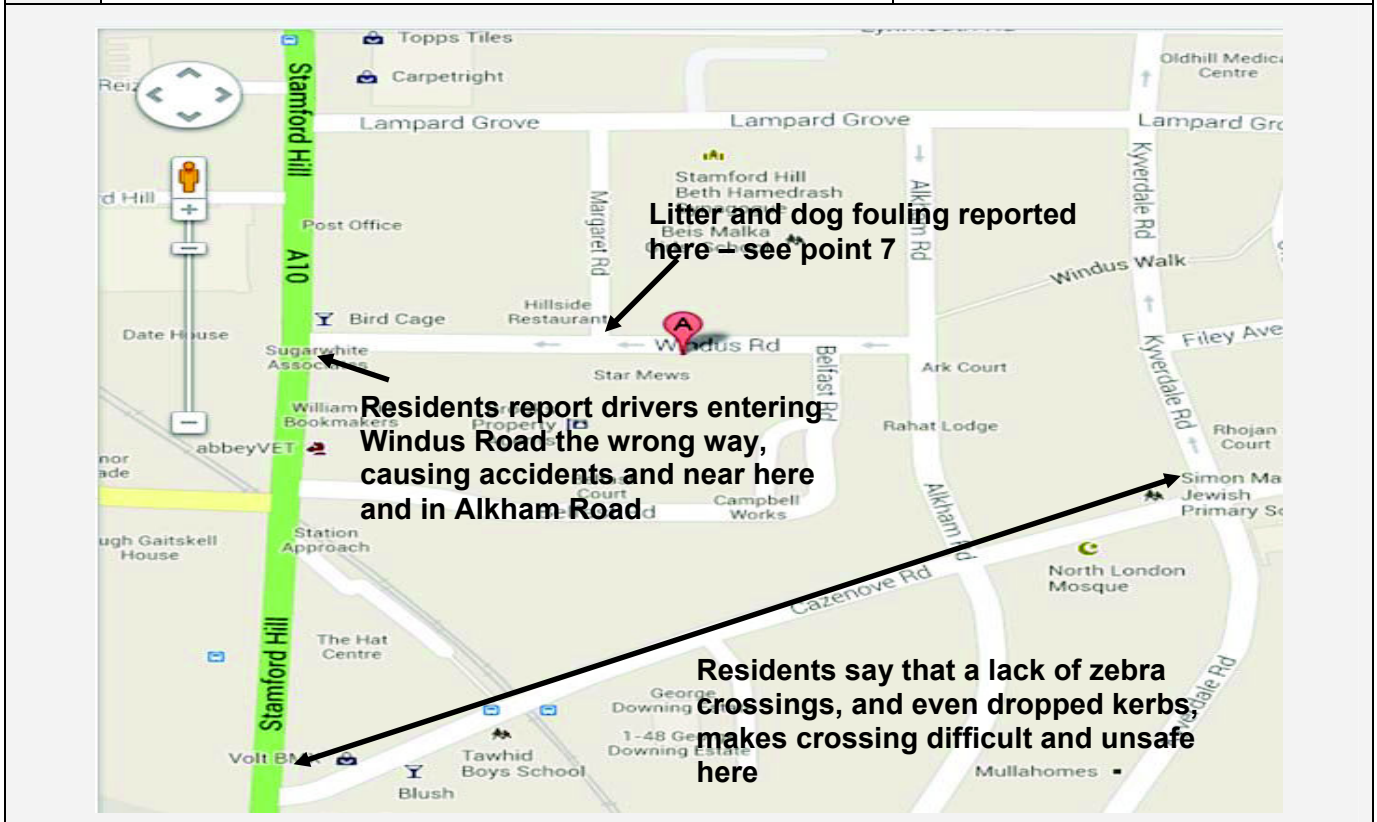

Arrangements finalised with Tops Tiles and Sainsbury's (Stamford Hill branches) for allowing parents and guardians to use car parks to 'Park and Stride' when dropping off and picking up children from schools and nurseries in the area. Residents reported common issue of drivers entering Windus Road from Stamford Hill, which has caused accidents and close shaves.</p> <p>B. The section of Cazenove Road between Stamford Hill and Simon Marks School. Despite this area having bus stops, local shops and being a throughway for the school and the train station, residents are concerned that there are no or few dropped kerbs, and no zebra crossings.</p>	<p>Elaine and Cllr Jacobson to carry out walk around during July.</p>



5.	<b>Elaine to keep Ward Forum informed of any testing of current traffic calming measures in the Ward.</b>	Elaine – ongoing through Tom.
6.	Elaine is meeting Sgt Gordon, Hackney Safer Transport Police on 3rd July. As part of meeting Elaine to raise residents concerns around horn usage by cars by minibuses in the Cazenove Ward. To report residents view that enforcement activity previously carried out against horn usage was successful, albeit in the short term. Elaine to ask Sgt Gordon around the viability of more enforcement action, and to get advice on how residents can report this.	Elaine to feedback to Ward Forum on 8 October.

9.	Nursery School Provision. A resident was encountering problems in securing whole day nursery places as opposed to multiple half days at the Fernbank Children’s Centre. Other residents said that Children Centres in Hackney were not always as user friendly as other boroughs (Camden) in offering full days care within the Nursery Education Funding scheme.
