		<p>conditions, as the Licensing sub-committee was satisfied that the licensing objectives would not then be undermined in the Shoreditch Special Policy Area.</p> <p>The sub-committee took into consideration that the Metropolitan Police and Environmental Enforcement had withdrawn their representation in advance of the hearing, following the applicant agreeing to the proposed conditions. It was noted that the application was amended to remove recorded music.</p> <p>After hearing from the applicant and considering the representations of the Other Person, the sub-committee believed that the measures which were put in place and the conditions agreed, was mitigation towards any negative impact in the area and on local residents. The sub-committee noted the applicants argument that the nature of the premises would be as a seated family orientated restaurant. And believed crucially that the requirement that alcohol was served to seated customers only and was ancillary to a substantial table meal, would mean that it would not add to cumulative impact in the area. It was also noted that all off-sales of alcohol would only be sold with a take away meal.</p> <p>Having taken all of the above factors into consideration the Licensing sub-committee were satisfied, that the licensing objectives would continue to be promoted in the Shoreditch Special Policy Area, particularly in relation to the prevention of crime and disorder and prevention of public nuisance.</p> <p>Planning Informative</p> <p>The applicant is reminded of the need to operate the premises according to any current planning permission relating to its use class, conditions and hours.
