|                |       | <ul style="list-style-type: none"> <li>• Delete Condition 10 as it is covered in condition 31.</li> </ul> <p>And the following additional conditions</p> <ul style="list-style-type: none"> <li>• All licensable activity will cease 30 minutes before the premises closes each day</li> <li>• A Dispersal Policy shall be submitted to and deemed acceptable by the Licensing Authority.</li> <li>• There shall be no open containers taken off the premises.</li> </ul> <p><b><u>Reasons for the decision</u></b></p> <p>The amended application has been approved, with the above amendments, as the Licensing sub-committee was satisfied that the licensing objectives would not be undermined.</p> <p>The sub-committee took into consideration that the Environmental Enforcement and the Metropolitan Police Service had withdrawn their representations, and agreed conditions with the applicant. Three representations were received from Other Persons two of which were withdrawn in advance of the hearing leaving one still maintained their objection to the application due to noise and anti-social behaviour issues affecting the local residents. The premises are situated in a residential area.</p> <p>The sub-committee took into consideration that local residents objected to the application because it would attract street drinkers to the area. In addition the local residents complained about noise nuisance from the premises, and there were concerns about anti-social behaviour from patrons. It was noted that the local residents made regular complaints to the Council</p> |

The applicant took on board the concerns raised by the local residents and is prepared to work with the local residents to resolve the issues.</p> <p>The sub-committee noted that no representations were received from the Council’s Planning Services. However, the applicant confirmed that they intend to apply for Planning Permission, and they did not object to a Planning Informative being added to this decision.</p> <p>The applicant lives in the borough and is familiar with the area. The premises is a small restaurant with limited capacity. The main focus will be on a fine dining experience offering quality food and high end wines for consumption with their meal. All tables will be booked in advance online. The applicant confirmed no alcohol will be served to patrons on the premises unless with a substantial meal. The applicant stated that they did not intend to run a bar on the premises. The sub-committee were informed that the restaurant will not provide take away or food for delivery to avoid litter and noise nuisance in the area. The applicant intends to offer the sale and supply of alcohol off the premises in sealed containers to patrons in the local area who wish to consume the wine at home. The applicant felt that the off sales to patrons will not add to the cumulative impact because they will have trained staff, and procedures in place to monitor patrons.</p> <p>The sub-committee having considered the representations from the applicant and the Other Persons felt that the premises would not unduly add to the cumulative impact of the area, and that the off-sales are not of the type that would attract street drinking. They noted that it is a food led premises and the supply of alcohol on the premises would be with a substantial meal at all times. They took into consideration that the premises had previous restaurant use, and patrons had to pre-book their table. The applicant demonstrated that they are a responsible operator who has invested in the area.</p> <p>The sub-committee were satisfied that the reduced hours together with additional conditions</p> |
