Missing Data

A full review of these records is being undertaken by Equiniti together with a member of the in house team from Hackney. Initial results have indicated a number of leavers which have either not been notified or not been processed; leaver details are being requested from the employers involved for these cases.

Other issues include missing pre-2014 earnings history, duplicates or an inability to match the data with the member record; again, clarification is bought sought from employers.

Missing Address

An address tracing exercise is being undertaken by Equiniti. This will include requesting records from employers where required.

Calculation/Data issues

These occur where the benefit statement calculation has not processed correctly. This is generally due to data either being incomplete or historically recorded in the wrong place. These are currently being investigated by Equiniti and will be re-run in the next 3 weeks.

Current Status of ABSs

All statements for deferred members have been sent; the following breakdown relates to statements for active members only.

Whilst further progress has been made on identifying the root cause of problems and issuing statements, many of the cases have proved more complex than anticipated, with a review of leaver information now also required from a number of employers. Additionally, we have faced unexpected staffing pressure with one of the most experienced members of our in house team now on long term sick leave. The Fund has therefore had to revise the planned rectification dates for the remaining statements.

Current Status of ABSs

All statements for deferred members have been sent; the following breakdown relates to statements for active members only.

Since the last report, good progress has been made on obtaining missing data from employers and establishing where members previously listed as active have in fact left the scheme. Nearly 1000 missing data queries have been resolved, with 498 statements now prepared and ready for printing and distribution. A further 298 queries have also been resolved, with statements now being prepared. 301 queries remain outstanding, with additional data required from employers to produce ABSs. The Fund's administrator, Equiniti, is liaising with employers to acquire the data; statements will be sent as soon as possible after receipt and verification of data.
