- 5.2 The Council therefore established a Standards Committee to help promote and uphold high standards of conduct amongst Members and co-opted Members.

6. BACKGROUND TO THE REPORT

- 6.1 This Annual Report is submitted to Council in line with best practice for the Council to maintain an overview of the work of the Standards Committee. This is the seventh Annual Report of the Standards Committee established by the Council following implementation of the Localism Act 2011 and the introduction of related ethical governance arrangements.
- 6.2 In upholding high standards the Committee monitors and makes recommendations on the Members' Code of Conduct and considers complaints made under the Code.

- 6.3 The Standards Committee during 2018/19 undertook work in the following areas, which are explained in further detail in Appendix 1 of this report:

 - Review of the Register of Members' and Co-optees Declaration of interests

 - Safety arrangements for Member surgeries

 - Update on the outcome of the Committee of Standards in Public Life Consultation
