8. OFFICER OBSERVATIONS

8.1 If the Sub-Committee is minded to approve the application, the following amended conditions should be applied the licence:

9 to read: "There shall be no people gathering outside the premises except for the 4 people sitting at the 2 outdoor seasonal tables"

21 to read: "There shall be no more than 38 patrons plus 4 patrons in the dedicated and delimited area outdoor- in attendance at any given time within all the 3 indoor areas/rooms of the premises"

9. REASONS FOR OFFICER OBSERVATIONS

- 9.1 No additional conditions have been proposed by the applicant or responsible authorities, although the applicant has indicated a willingness to accept use of plastic glasses for those seated in outside areas.
- 9.2 The applicant has proposed amendment to current wording of conditions 9 and 21.

10. LEGAL COMMENTS

- 10.1 The Council has a duty as a Licensing Authority under the Licensing Act 2003 to carry out its functions with a view to promoting the following 4 licensing objectives;
 - The Prevention of Crime and Disorder
 - Public Safety
 - Prevention of Public Nuisance
 - The Protection of Children from Harm
- 10.2 It should be noted that each of the licensing objectives have equal importance and are the only grounds upon which a relevant representation can be made and for which an application can be refused or terms and conditions attached to a licence.

11. HUMAN RIGHTS ACT 1998 IMPLICATIONS

- 11.1 There are implications to;
 - *Article 6* Right to a fair hearing
 - *Article 14* Not to discriminate
 - Balancing: Article 1- Peaceful enjoyment of their possession (i.e. a licence is defined as being a possession) with Article 8 Right of Privacy (i.e. respect private & family life) to achieve a proportionate decision having regard to the protection of an individuals rights against the interests of the community at large.

- The CCTV System will be extended to cover more areas of the Premises.

- the use of special plastic glasses may be introduced to serve customers sitting at the outdoor seasonal tables if Authorisation for outdoor seating is granted.

- the current 4 Personal Licence Holders working for the business (out of the current 8 employees) will be taken to 8 (out of 10/11 forecast employees) if this extension is granted

- there will be no admittance to any person under 18 years of age even if accompanied by an adult.

b) The prevention of crime and disorder

The CCTV System that was installed following the granting of the current Licence in July 2014 - and has been recently updated - could be extended further into the Mezzanine and above the pavement outdoor (in order to cover the outdoor tables if this Variation is granted).

c) Public safety

If outdoor tables are allowed by the granting of this Variation and by the Relevant Hackney's Street Trading Service, and if the Relevant Authorities believe that only special plastic glasses should be used when serving wine to the customers sitting at these tables in order to allay any concerns regarding Public Safety and the Prevention of Crime and Disorders, the Applicants are willing to introduce this style of glasses even if their Business model and the upmarket position of their trading would advice for the use of traditional crystal glasses.

d) The prevention of public nuisance

There is no loud music played within the Premises, only low key background ambience music that allow normal low voice conversation among the patrons.

If outdoor tables and chairs will be permitted, the staff serving at these tables will make sure that they will be cleared of glasses and bottles as soon as the customers leave and regularly check and clean - when needed - the ashtray and the pavement outside the shopfront.

e) The protection of children from harm

- There is no admission to underage persons in the premises not even if accompanied by adults (except when customers with children enter the wine shop to buy bottles of wine to be taken away for Consumption Off the Premises).

- Passione Vino employs only skilled Sommeliers specialising in Craft and Organic Italian Wines; if, when employed, they don't have already a Personal Licence issued by an English Council, they will, usually, be trained on the England & Wales Licensing Legislation and asked to apply for a Personal Licence. If the Variations applied for will be granted, there are plans to have 2 Personal Licence Holders on duty at any time when Alcohol is on sale for Consumption On the Premises



LICENSING PLAN



◆ € ◆ Police make the following objections in relation to the application to vary the Premises Licence at PASSIONE VINO, 85 LEONARD STREET, LONDON, EC2A 4qs for the following reason(s);

This premises is located within the Shoreditch Special Policy Area. It is set just off Great Eastern Street and is very busy at all times of the day and night. It is often busier during the later hours – evenings into the early hours – as there are many other hotels, bars, clubs and restaurants surrounding this premises.

The application seeks to extend the supply of alcohol for consumption on the premises by 30 minutes each day and to extend this supply throughout the whole of the premises – where it was previously restricted to the basement. The applicant proposes to remove condition 21 to achieve this, and this causes concern for the police. This condition was initially included on the licence to prevent the venue from becoming a bar. The premises was granted a licence for a wine shop that would host wine meetings and tastings. The removal of this condition and the inclusion of the rest of the premises indicates that this premises is going to become a bar, with vertical drinking, which is exactly what this licence was conditioned against. Has the nature of the business or the business model now changed?

Shoreditch has changed significantly during the past year or so and has seen a marked increase in the amount of violent crime, ASB and disorder. The applicant has not provided any details of how they intend to demonstrate that they will not add to the cumulative impact that is currently being experienced in these areas as set out in LP10 of LBH's Statement of Licensing Policy. Although this premises is not set on the main road, because of the introduction of new premises and hotels, this street has seen an increased footfall, which would in turn could mean the potential for an increase in ASB, crime and disorder.

Police look forward to hearing from the applicant soon with what policies and procedures that have in place that will ensure that they will not add to the cumulative impact.

I write to make a representation in relation to this application as the premises is located within the Shoreditch Special Policy Area (SPA). The SPA is area that has been identified as suffering from the negative cumulative impact of the concentration of licensed premises in the area. The proposed variation could lead to a negative impact on the promotion of the licensing objectives, in particular, the prevention of crime and disorder and the prevention of public nuisance. As Director of Public Health (a responsible authority under the Licensing Act 2004), I wish to make a representation against the application to vary the current license for **Passione Vino**

The City and Hackney Public Health function recognises the role that licensed premises play in contributing to the local economy, but the dense availability of alcohol has a significant impact on the health and wellbeing of many of the borough's residents.

Tackling alcohol misuse is key to achieving the aspirations of Hackney's Health and Wellbeing Strategy. We want to establish an environment that recognises the role of alcohol in our society, whilst minimising the significant health damage caused by alcohol misuse. Licensing is an important component in the wider efforts to reduce this harm.

This representation is made under the **prevention of crime and disorder and the prevention of public nuisance** licensing objectives.

The application is for a venue within the Shoreditch Special Policy Area (SPA). As laid out in the Council's Licensing Policy, and under **LP10**, where a relevant representation is made to any application within the area of the Shoreditch SPA, the application should demonstrate that the proposed activity and the operation of the premises will not add to the cumulative impact that is currently being experienced in these areas.

Shoreditch has been defined as a cumulative impact area. I am concerned that if this application is granted it will increase the availability of alcohol for consumption off premises. There is increasing recognition of the impact that high density availability





has¹, which could lead to an increase in public nuisance, crime and disorder and impact adversely on the health of both those consuming the alcohol but also of others who come into contact with them.

The area already has sufficient premises to meet demand and additional outlets supplying alcohol with expanded capacity both internally and in external areas to the venue will be detrimental to the local residents in terms of noise and disturbance, anti-social behaviour and crime.

The area within which this premise is located has high incidences of crime and violence, including those that are alcohol related. The information below is drawn from Bullseye and Safestats, a service within the Greater London Authority that hosts data from emergency services and other agencies. This data shows that, within 500m of the premises:

- There were **273** alcohol related incidents
- **50** alcohol related incidents involved those aged under 26 years
- **102** assaults were recorded by the London Ambulance Service

According to the council's Licensing database of premises allowed to sell alcohol, there are **72 on licence premises** and **32 off licence premises** within 500m of the application venue, with a further **119 having a licence for on and off sales**.

Based on the information provided and the conditions outlined in LP10, **the Public** Health function recommends that the variations on the application for a licence to supply alcohol be refused.

Dear Councillors,

I am writing to object to the proposal to extend the license at 85 Leonard Street (Passione Vino) to 22:30 inside their premises and to allow customers to drink on a portion of the outdoor pavement.

SPA context:

The location of 85 Leonard Street is right next to the Griffin Pub, Casita & Home, which are all located in this part of Leonard/Ravey street and no more than a few hundred yards from Book Club on Leonard Street. Residents, supported by our ward councillors, have submitted evidence of the increasing negative impact in this quiet area of Shoreditch. Councillor Plouviez is aware of submitted examples, and Councillor Sellman committed to Feryal and residents that the SPA boundary would be reassessed due to the fast- developing nature of our streets.

In addition to the large/established venues - there has been an expansion of tacky venues such as Rascals and Ballie Ballerson. Even "restaurants" are contributing to all day drunkenness, due to the "bottomless brunch" trend.

Local services including Environmental noise team; local police; the "out of hours" incident reporting website are already unable to prevent the negative impacts on residents, and neighbouring properties.

Licencing context:

The license to extend the supply of alcohol and to allow customers out onto a portion of the outdoor pavement must be rejected on the grounds of the high risk of adding to existing cumulative negative impact including:

- Public health and safety: on street drinkers blocking pavements outside the Griffin and Book club; people staggering into the road; urinating on private property all across Leonard & Ravey Street.
- Public nuisance: littering, noise nuisance from drivers parking under residential windows, at all hours; loud music (from car stereos, and outdoor drinking venues); drunk and shouty groups, including young girls vomiting on private property at 3-4pm (not just 3-4am).
- Crime and disorder: pre-loading, and drug taking in the street, before going to clubs; dangerous driving; and violent behaviour.

In addition, existing venues in this exact part of Shoreditch already have licensing conditions which this would challenge or exacerbate the issue of their already poor compliance to.

Dipesh Confectioners – next door to 85 Leonard Street (Passione Vino) has a license for off-sales only, which requires them to close earlier than 22:30 to comply with.

The Griffin has a condition that no people should be outside drinking on the Leonard Street pavement, on the same side of the road as Passione Vino right from 91 to 75 Leonard Street. Passione Vino have applied for a license to allow people to drink outside almost exactly in the centre of the area the Griffin are forbidden to allow people to drink (which is a condition for the record they do not 100% comply with!!).

This section of Leonard street, next to Ravey Street and adjoining Great Eastern street is the most saturated part of the Shoreditch area, outside of SPA. It would be totally nonsensical and unbearable for local residents to allow an extension to a license to attract and empty further inebriated customers onto this part of Shoreditch. It will have a dramatic cumulative impact that cannot be ignored.

"Future Shoreditch" context:

We are in an area that is strategically planned to undergo intensive COMMERCIAL development and provide economic growth for the Borough and London. Several sites, in the Conservation Area, are already highlighted for demolition and newbuild office construction. Very few sites are as closely surrounded by residential properties as in Leonard Street.

Many developers and businesses in this area are driven by profit, profit which comes from Alcohol sales.

The real cost- the impact on the Local community, residents, and public resources - is unsustainably high.

Granting further licensing and negligently allowing venues to attract and empty further customers onto this saturated part of Leonard Street would be catastrophic in destroying trust in the council to effectively manage the area and licensed premises.

Please ensure that this Licence application is rejected.

Good afternoon Mike,

Thank you for re-scheduling the Passione Vino hearing to the evening of the 10th October, Unfortunetly neither my wife or I are able to attend the hearing on the 10th either.

However, please ensure my objections are put forward, to further support my objections please find attached pictorial evidence from Leonard street. All pictures were taken in the last four weeks.

As you can see from the attached images, upwards of 100 patrons of The Griffin (Casita & Home) regularly gather across both sides of Leonard street, where Leonard street crosses with Ravey Street.

The implications of this are;

-Huge congestion along Leonard street, creating a highly unsafe environment for both pedestrians and motorists as they regularly meet in the road.

-Excessive noise, which continues into the early hours of the morning. The noise is created from the excess of people, smashed glasses and the arrival of Taxi's to collect Patron's for the entirety of every evening.

-Antisocial behaviour. The mass of people often creates confrontation amongst the Patron's, with The Griffin security staff member or motorist/taxi's as they clash on the road.

-Litter/Pollution. It is a regular occurrence to find broken glass, bodily fluids & litter thorough the street and even on our door step of a morning.

These issues are compounded by a similar number of Patrons from the Book Club no more than 15meters away replicating exactly the same issues and behaviour!!

The Griffin have several restriction on their license conditions;

Point 5 - Customers shall not smoke on Ravey Street

Point 10 - Customers shall not consume drinks from glass

Point 17 - A minimum of one SIA door staff to be present per 100 customers

Point 18 - No customers outside post 11pm

These restrictions are already blatantly being abused! The pictures above show customers smoking, drinking from glass bottles and wine glasses, over 100 customers outside, let alone inside (The Griffin only ever has one SIA Doorman).

With the existing licenses already clearly being abused and the level of impact from inebriated patrons at excessive levels, it is utterly impossible for any license extensions to be considered whilst upholding the licensing policy objectives.

-The licensing changes requested by Passione Vino MUST be firmed denied.

-The license request by Zabeel Hotel MUST only be granted on the basis of the following conditions being applied;

-No customers being allowed to exit the hotel to smoke on Leonard Street (All smokers must be directed to the Great Eastern Street entrance/smoking area)

-The bar to only be licensed until 11.00pm

-No entry to the Hotel, except for Hotel residents post 11.00pm



Annex 1 - Mandatory Conditions

Supply of Alcohol

- 1. No supply of alcohol may be made under the premises licence:
 - (a) At a time when there is no designated premises supervisor in respect of the premises licence.
 - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
 - 6.1. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sales or supply of alcohol.
 - 6.2. The policy must require individuals who appear to the responsible person to be under 18 years if age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 7. The responsible person shall ensure that:
 - a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
 - beer or cider:1/2 pint;
 - gin, rum, vodka or whisky: 25ml or 35ml; and
 - still wine in a glass: 125ml; and
 - b) customers are made aware of the availability of these measures.

Annex 2 – Conditions consistent with the Operating Schedule

- 8. No cans of beer, lager or cider of any strength will be sold.
- 9. There shall be no people gathering outside the premises at any time.

Conditions derived from Responsible Authority representations

- 10. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of a Metropolitan Police Crime Prevention Officer. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available as soon as practicable upon the request of Police or authorised officer throughout the preceding 31-day period.
- 11. Any staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member must be able to show a Police or authorised council officer recent data or footage when requested.
- 12. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.
- 13. Signs will be prominently displayed at all exit points reminding customers to leave quietly and respect local residents.
- A challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as driving licence or passport.
- 15. An incident log shall be kept at the premises, and made available on request to an authorised officer of the council or the police, which will record the following.
 - a. All crimes reported:
 - b. All ejections of patrons
 - c. Any complaints received.
 - d. Any incidents of disorder.
 - e. Any faults in the CCTV system or searching equipment or scanning equipment.
 - f. Any refusal of the sale of alcohol.
 - g. Any visit by a relevant authority or emergency service.
- 16. Premises to operate zero tolerance policy to drugs and comply with Hackney

Police and Council Community safety unit drugs and weapons policy where appropriate.

- 17. An adequate and appropriate supply of first aid equipment and materials shall be available on the premises.
- 18. All staff will be given refresher training every two years on the legislation relating to the sales of alcohol to underage persons and drunken persons.
- 19. The licence holder shall maintain a dedicated telephone number of the Designated Premises Supervisor for use by any Responsible Authority or any person who may wish to make a complaint. This contact number shall be provided to licensing authority, police and to any local residents upon request.
- 20. There shall be no partly consumed or opened bottles removed from the premises at any time. All alcohol off sales will be wrapped and bagged/boxed
- 21. There shall be no more than 18 patrons in attendance at any wine meetings and tastings, which will take place in the basement area only.
- 22 Patrons shall not be allowed to take open containers outside of the premises at any time.
- 23. There shall be no children allowed in the premises at any time

Annex 3 – Conditions attached after a hearing by the licensing authority

24. Any recorded music played at the premises will be at a background level only that allows a face to face conversation, at normal speech level.
