6. GUIDANCE CONSIDERATIONS

6.1 The Licensing Authority is required to have regard to any guidance issued by the Secretary of State under the Licensing Act 2003.

7. POLICY CONSIDERATIONS

- 7.1 Licensing Sub-Committee is required to have regard to the London Borough of Hackney's Statement of Licensing Policy ("the Policy") adopted by the Licensing Authority.
- 7.2 The Policy applies to applications where relevant representations have been made. With regard to this application, policies, LP1 (General Principles), LP2 (Licensing Objectives), LP4 ('Off' Sales of Alcohol) and LP11(Cumulative Impact General) are relevant.

8. OFFICER OBSERVATIONS

8.1 If the Sub-Committee is minded to approve the application, the following conditions should be applied the licence:

Supply Of Alcohol (On/Both)

- 1. No supply of alcohol may be made under the premises licence:
- (a) At a time when there is no designated premises supervisor in respect of the premises licence.
- (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made

or authorised by a person who holds a personal licence.

- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. 5.1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sales or supply of alcohol.
- 5.2 The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 5.3. The policy must require individuals who appear to the responsible person to be under 18 years if age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-

A. a holographic mark or

- B. an ultraviolet feature.
- 6. The responsible person shall ensure that:
- a) where any of the following alcoholic drinks is sold or supplied for

consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:

- beer or cider: 1/2 pint;
- gin, rum, vodka or whisky: 25ml or 35ml; and
- still wine in a glass: 125ml; and
- a. these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- b. where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

Minimum Drinks Pricing

- 7. 7.1 A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 7.2 For the purposes of the condition set out in paragraph 7.1 above -
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979:
- (i) "permitted price" is the price found by applying the formula P = D+(DxV)Where -P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (b) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence,
- (ii)the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (d) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 7.3 Where the permitted price given by Paragraph 8.2(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 7.4 (1) Sub-paragraph 7.4(2) below applies where the permitted price given by Paragraph 7.2(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days

beginning on the second day.

Door Supervision

8. Each individual who is to carry out a security activity at the premises must be licensed by the Security Industry Authority.

Conditions derived from operating schedule

- 9. No public to enter the building and all activities onsite will be supervised the onsite events and security team.
- 10. Clear restrictions to be in place with regards to operating the spaces, noise and management of the event.
- 11. Children to be accommodated by an adult with most of the events being private weddings or Community bookings.
- 12. All events to be pre-booked and have a Council Representative present to oversee activities and manage the safe operation of the site.
- 13. All events to be private or commercial events that go through full vetting during the enquiry stages.

Conditions derived from Responsible Authority representations

- 14. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of a Metropolitan Police Crime Prevention Officer. All public areas and each entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or authorised officer.
- 15. There shall be a staff member from the premises who is conversant with the operation of the CCTV system on the premises at all times when the premises are open to the public. This staff member must be able to show a Police or authorised council officer recent data or footage when requested
- 16. Signs will be prominently displayed at all entrance and exit points reminding customers to leave quietly and respect local residents.
- 17. A challenge 25 Proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence or passport
- 18. All staff shall receive training on the legislation relating to the sales of alcohol to underage persons and drunken persons and shall have refresher training every 12 months. There shall be written records of such training which will be kept on the premises and produced to a police officer or other authorised officer upon request.
- 19. An incident log shall be kept at the premises, and made available on request to an authorised officer of the council or the police, which will record the following.

- a) All crimes reported to the venue:
- b) All ejections of patrons
- c) Any complaints received.
- d) Any incidents of disorder.
- e) Seizure of drugs or offensive weapons.
- f) Any faults in the CCTV system.
- g) Any refusal of the sale of alcohol.
- h) Any visit by a relevant authority or emergency service.
- 20. The premises shall have a written Dispersal policy that ensures all patrons exiting the venue are encouraged to leave the area. This policy shall be made available to police on request.
- 21. Whenever licensable activity is taking place and the number of customers exceed 40 persons there shall be a minimum of one SIA employed at the venue. Additional SIA shall be employed on a risk assessment basis. All door supervisors shall enter their full details in the premises daily register at the commencement of their work. They shall record their full name, home address and contact telephone number, their SIA registration number and the times they commence and conclude working. If the door supervisor is provided by an agency, the name, registered business address and contact telephone number will also be recorded. This register will be made available to police or other authorised officer upon request.
- 22. The venue shall have on display contact detail for local minicab/tax services to assist with the dispersal of customers
- 23. There shall be no glass, drinks or open containers taken past the boundary of the courtyard at any time
- 24. Whenever there is alcohol being sold or consumed on the premises there shall be at least 1 SIA positioned at the gate to the courtyard
- 25. The use of the outside area shall not be after 2100hours save for a maximum of 5 smokers
- 26. After 2100hours the door and windows to the premises shall be kept closed in order to prevent disturbance to local residents
- 27. Each event shall have a risk assessment completed and where deemed necessary a suitable number of stewards/staff shall be employed to assist with dispersal

9. REASONS FOR OFFICER OBSERVATIONS

9.1 Conditions 9 to 13 are derived from applicants operating schedule. Conditions 14 to 27 have been proposed by the Police. The proposed conditions have been accepted by the applicant.

10. LEGAL COMMENTS

- 10.1 The Council has a duty as a Licensing Authority under the Licensing Act 2003 to carry out its functions with a view to promoting the following 4 licensing objectives;
 - The Prevention of Crime and Disorder
 - Public Safety
 - Prevention of Public Nuisance
 - The Protection of Children from Harm
- 10.2 It should be noted that each of the licensing objectives have equal importance and are the only grounds upon which a relevant representation can be made and for which an application can be refused or terms and conditions attached to a licence.

11. HUMAN RIGHTS ACT 1998 IMPLICATIONS

- 11.1 There are implications to;
 - *Article 6* Right to a fair hearing
 - *Article 14* Not to discriminate
 - Balancing: **Article 1-** Peaceful enjoyment of their possession (i.e. a licence is defined as being a possession) with **Article 8** Right of Privacy (i.e. respect private & family life) to achieve a proportionate decision having regard to the protection of an individuals rights against the interests of the community at large.

The building will undergo full risk assessments to ensure the safe operation of the site. All events will be pre-booked and have a Council Representative present to oversee activities and manage the safe operation of the site. The Hackney Venues team will ensure that the building is at all times up to date on RA's, PPM and operated in a safe and controlled environment.

Any booking will undergo scrutiny prior and risk assessments & insurance documents need to be provided by the client where appropriate.

b) The prevention of crime and disorder

All our events will be private or commercial events that go through full vetting during the enquiry stages. Any inappropriate or concerning events will be denied at this stage and can also be cancelled if we believe the content not to be suitable. Any events that are above 40 people, involves alcohol consumption or pose a higher risk will require security via our Council contracted supplier CIS and clear terms and conditions are lined out for each event. Any disorder on the day will result in the event being closed early.

c) Public safety

All events will be assessed and measures put in place depending on event on top of the standard operating procedures. Where large numbers or alcohol is provided we will have the Council contracted security guards onsite to control the event. An events related risk assessment and public liability insurance will be provided by the organiser.

No external people are able to enter the building and all activities onsite will be supervised by the onsite events and security team.

d) The prevention of public nuisance

Clear restrictions will be in place with regards to operating the spaces, noise and management of the event. The security team onsite for any larger events will monitor the event and its guests and will intervene immediately where required. Police will be called in case of any escalation which is the worst case scenario.

e) The protection of children from harm

Children will generally have to be accommodated by an adult with most of our events being private weddings or Community bookings this is generally well managed. The venue is enclosed which won't allow public to enter site during an event. All events will be vetted for suitability and risk assessments will be required. Should concerns arise these need to be mitigated or the event will not go ahead.





<u>Supporting Statement - Licence sub committee - The Glass House, Springfield Park</u>

Hackney Venues is a venture run by the London Borough of Hackney to operate venues within the borough offering a service where clients, local business and communities can host a range of different styles of events within the spaces. We currently operate 3 venues within the borough, Clissold House, Stoke Newington Town Hall and Hackney Town Hall. We have recently also taken on The Glass House located within Springfield Park. Hackney Venues has been operating for ten years and holds a high valued reputation internally and externally.

Each venue within the portfolio operates within the same manner, we hire out the spaces externally for events such as community classes, local business away days, wedding ceremonies and receptions, corporate dinners / conferences, product launches & exhibitions.

We do not accept events such as 18th & 21st birthday parties, or any type of club / promoted style of event. Whilst it is permitted to allow this style of event within our spaces, the decision to not do so is because of the higher risk of damage to our buildings (which are grade II listed), along with the potential reputational damage. We have always been conscious of how we manage events in accordance with the premises license and how we will prevent nuisance behaviour. Our team is run by event professionals and are aware of the high level of standards required. We are mindful when confirming an event with a client that we are responsible for ensuring that the event we host is appropriate under our terms and conditions.

Accredited caterers go through a vetting process and have to provide evidence that a personal license holder will be on site at all times. In addition to this we require a signed contract which states that it is strictly forbidden to let clients or guests access any alcohol on site unless it's served to them by a professional bar attendant (either served at the table or behind a bar). The exception to this is wine on the tables with food, but this is limited to a glass and a half per person which is controlled by the caterer on site during the event.

All records of personal licenses and signed venue guidelines are obtained by the Venues Team, and the event manager working onsite is responsible for upholding the licensing objectives, as personal license holders themselves.

We have reduced the operational hours of The Glass House, which differs from the other venues we operate. Operational running times for this space are;

- Sunday Thursday 08:00 23:00 (bar closed and music off at 22:30)
- Friday Saturday 10:00 00:00 (bar closed and music off at 23:30)

The doors to the terrace need to be closed by 21:00 each day and no activity can take place after this time on the terrace.

During all events we have a representative from Hackney Council on site. The Event Manager will oversee the running of the day, working closely with security and suppliers. Security is mandatory for all commercial events where alcohol is consumed on site. Once the event is finished security guards escort guests to and from the space to the entrance of the park when leaving. Security plays a key role in communicating with the event manager

and catering manager throughout the event to ensure no disruption is happening, if this is the case and noise nuisance behaviours arise then this will be addressed accordingly.

We work with a local taxi company based in Stoke Newington who we offer clients to book once the event is finished, this can be pre-booked prior to the event taking place.

We have been in communication with Cllr Stienberger who has acted as a representative of the community within Stamford Hill and have been working with him to ensure the right message is communicated to local residents about how we operate as a service and our vision for the new space.


One of the concerns raised by the local community was that the venue was going to be a pub and open seven days a week serving alcohol. This is not the case and we have communicated this strongly to local residents. In addition we have designed an information flyer highlighting some of the main concerns raised by the community and addressing them individually. This was distributed to 2538 properties within a 400m radius of the venue.

It was highlighted that there could potentially be an opportunity for us to work with a local caterer who was recommended by Cllr Steinbergrer. This caterer provides a popular catering service within the local community. Our meetings to date have been positive and we are now in the process of including them on our accredited caterers list. The caterer has given positive feedback on the space and hopes to help bring local business, community events and weddings to the space.

Finally we are planning a community open day that is going to be held on Tuesday 10th August. This will be a chance for local residents and park users to come and see the space, meet the team who will be on site and have a tour of the venue. The team will be able to engage with the local community and explain the different options we have available. We will also be demonstrating what an event would look like in the space. The local caterer has agreed to showcase their catering for the event.

To date there has been positive feedback from potential clients who wish to book the venue, with events ranging from community away days to working group meetings, from wedding ceremonies to events. An alcohol and entertainment licence is essential when operating such a commercial hire venue and this space will run identically to all of our other spaces within Hackney. I hope all of the points outlined above have addressed any concerns.
