Police withdraw our representaons in relaon to the applicaon to vary the Premises Licence at Teo's, 123-125 Kingsland High Street, London, E8

Police agree to the propose amendment to Condition 13 and agree with the applicant that it should now begin 'On the ground floor.....'

1. Basement can only be use for pre-booked events, and they must be under the supervision of Mr Salman Kurt. Mr Kurt must be present at the venue throughout the funcon. There shall be a guest list for each event supplied by the hirer and this guest list shall be made available to police or other authorised officer on request..
2. There shall be a maximum of 10 smokers outside the premises at any one me. This shall be monitored by staff'.
3. There shall be a maximum of 65 person in the basement, including staff, at any one me.

Police have been sent the dispersal policy for the venue and are sasfied that this variaon will not undermine the licensing objecves.

I totally understand. Thank you for your e mail. I'm glad we are in agreement with the conditions.

My name is Onur Siroren (O.J) from Tetto's [123-125 Kingsland high street, E8 2PB](#). I am the operations manager and i assist Mr Kurt with this application.

Mr Salman Kurt and I received the representations you made. We read them very carefully and our reply is as follows:

We are more than happy to accept the following conditions put forward:

1-The basement shall be used for pre-booked events only. There shall be a guest list for each event supplied by the hirer and this guest list shall be made available to police or other authorised officer on request'. 2- There shall be a maximum of 10 smokers outside the premises at any one time. This shall be monitored by staff.

We look forward to discuss the capacity of the basement at your earliest convenience.

Relating to the condition 21, please find attached the dispersal policy. Also attached is a document we prepared for your views explaining our operation, policies and procedures will be put in place to ensure that Tetto's will not add to the cumulative impact in Dalston nor undermine the licensing objectives.
