1. **Summary**

- 1.1. Ismail Toprack has made an application for a premises licence under section 17 of the Licensing Act 2003.
- 1.2. The application seeks to authorise late night refreshment on Monday to Saturday.
- 1.3. The premises are located within the Dalston Special Policy Area.
- 1.4. The applicant is seeking authorisation for the following licensable activities and times:

5. **Guidance Considerations**

- 5.1. The Licensing Authority is required to have regard to any guidance issued by the Secretary of State under the Licensing Act 2003.

6. **Policy Considerations**

- 6.1. Licensing Sub-Committee is required to have regard to the London Borough of Hackney's Statement of Licensing Policy ("the Policy) adopted by the Licensing Authority.
- 6.2. The Policy applies to applications where relevant representations have been made. With regard to this application, policies, LP1 (General Principles), LP2 (Licensing Objectives), LP3 (Core Hours) and (LP10 - Special Poluy Area) are relevant.

7. **Officer Observations**

- 7.1. If the Sub-Committee is minded to approve the application, the following conditions should be applied the licence:

Conditions derived from operating schedule

1.The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of a Metropolitan Police Crime Prevention officer. All entry and exit points will be covered to enable frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum of 31 days with time and date stamping. Recording shall be made available immediately upon the request of Police or authorised officers throughout the preceding 31 days period.

2.A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when it is open to the public. This staff member shall be able to show the Police or the Licensing Authority recent data or footage with the absolute minimum of delay when requested.

3.The licence holder shall maintain an Incident Book at the premises to record the following:--all crimes reported to the venue--all ejections of patrons--any complaints received--any incidents of disorder--seizures of drugs or offensive weapons and their location.--any faults in the CCTV system--any visits by a relevant authority or emergency service.

4.Premises to operate a zero-tolerance policy to drugs and comply with the Hackney Police/Council Community Safety Unit Drugs and Weapons Policy where appropriate.

5.No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.

6.Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.

7.There shall be no more than 48 patrons on the ground floor after 23:00 until close at any one time.

8.After 23:00 there shall be no more than 4 customers smoking outside of the premises at any one time.

8. **Reasons for Officer Observations**

8.1. Conditions 1 to 8 are derived from the applicant's operating schedule.

9. **Legal Comments**

9.1. The Council has a duty as a Licensing Authority under the Licensing Act 2003 to carry out its functions with a view to promoting the following licensing objectives;

- The Prevention of Crime and Disorder
- Public Safety
- Prevention of Public Nuisance
- The Protection of Children from Harm

9.2. It should be noted that each of the licensing objectives have equal importance and are the only grounds upon which a relevant representation can be made and for which an application can be refused or terms and conditions attached to a licence.

10. **Human Rights Act 1998 Implications**

10.1. There are implications to;

- **Article 6** – Right to a fair hearing
- **Article 14** – Not to discriminate
- Balancing: **Article 1**- Peaceful enjoyment of their possession (i.e. a licence is defined as being a possession) with **Article 8** – Right of Privacy (i.e. respect private & family life) to achieve a proportionate decision having regard to the protection of an individuals rights

against the interests of the community at large.



Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets

consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.

- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of an EEA state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the EEA family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the EEA national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

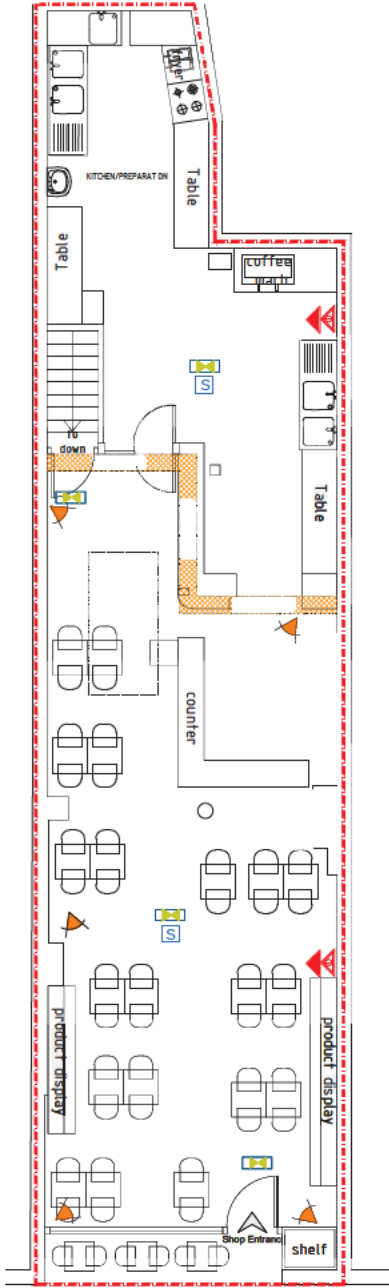

All entry and exit points will be covered to enable frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum of 31 days with time and date stamping. Recording shall be made available immediately upon the request of Police or authorized officers throughout the preceding 31 days period.
2. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when it is open to the public. This staff member shall be able to show the Police or the Licensing Authority recent data or footage with the absolute minimum of delay when requested.
3. The licence holder shall maintain an Incident Book at the premises to record the following:--all crimes reported to the venue--all ejections of patrons--any complaints received--any incidents of disorder--seizures of drugs or offensive weapons and their location.--any faults in the CCTV system--any visits by a relevant authority or emergency service.

6. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.
7. There shall be no more than 48 patrons on the ground floor after 23:00 until close any one time.
8. After 23:00 there shall be no more than 4 customers smoking outside of the premises at any one time.

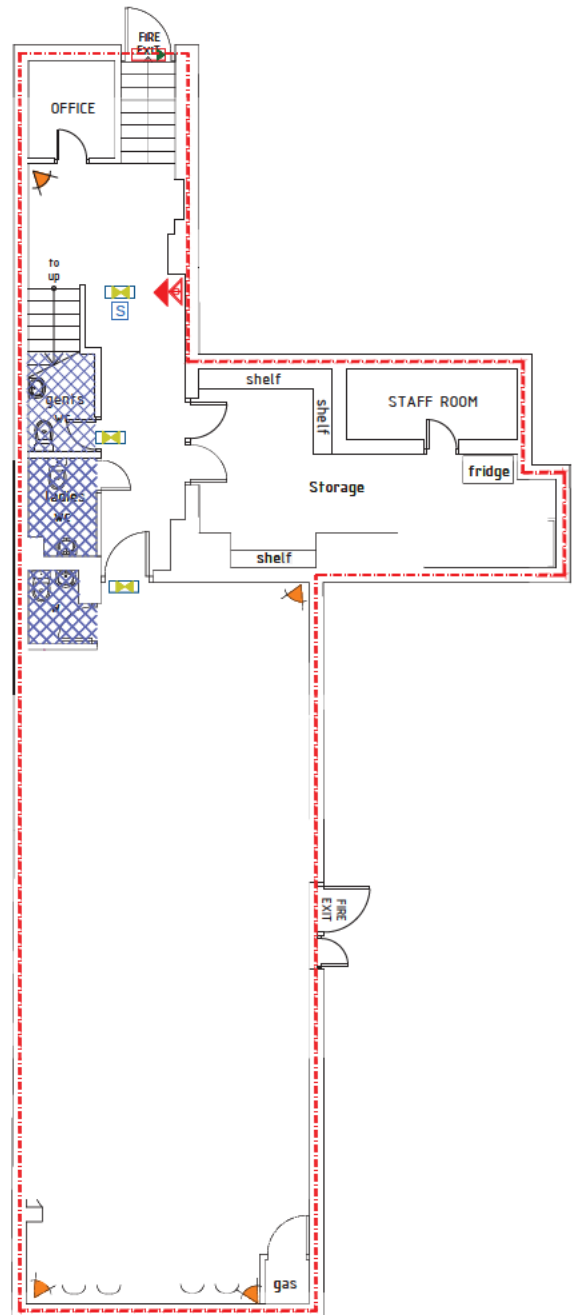
GROUND FLOOR PLAN

The venue is in the Dalston Special Policy Area, and as LP10 of the Council Licensing Policy states, the applicant will need to demonstrate that the proposed activity and operation will not add to the cumulative impact that is currently being experienced in the area. The application does not acknowledge its location in the SPA, and does not directly address what measures will be taken to mitigate any impact.

There is a current licence at the premises that allows both the supply of alcohol and the provision of Late Night Refreshment until 2340hrs Sunday – Thursday, and 0040hrs Friday and Saturday. These hours are already in excess of the Core Hours mentioned in LP3 of the policy. Police do acknowledge that this new application does not require the sale of alcohol and is purely for Late night refreshment, however the hours are still far in excess of the policy. Later hours may be considered if robust measures are put in place, however there are no robust measures offered at this time.

Police would like to know what they intend to do with the current licence at the premises should a new one be granted. Police would ask that the unwanted licence is surrendered.

Police have met with the applicant and his representative during which discussions concerning the inside and the basement toilets were discussed. The inside seating will now not be used after 2300hrs and the basement will not be utilised at all.

The proposed conditions also limit smokers outside after 2300hrs to 4. How will this be managed?

Police also note the Non-Standard hours which are again, far outside the Core Hours and carry no additional measure either. Police request that these are removed, and should additional hours be required then TENs can be utilised.

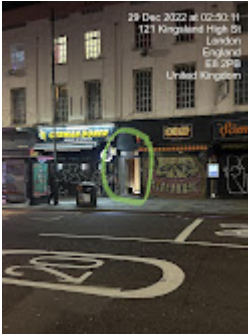

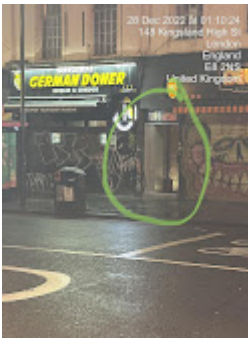

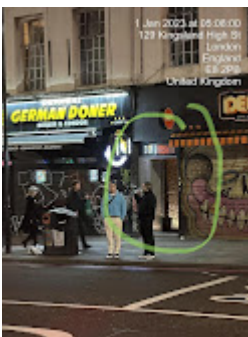

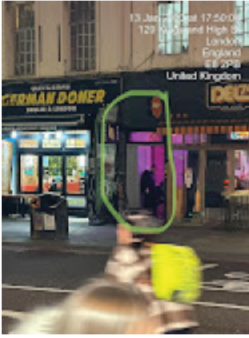

5. Late night opening hours will attract **further crime** and disorder in the area which must be avoided.
6. Smell and odor from the extract will cause further nuisance to the area.
7. The restaurant basement does not have trading license but carrying on trading illegally as café.
8. Basement café is trading **24 hours** without any sort of license.
9. The café is trading as **illegal gambling** spot for the local community without premises license.

The premises below as made a similar application quite recently which was rejected.

There are a number of kebab shops in the immediate vicinity and they are all a nuisance and more of the same would make things even worse.

Drunken customers hanging around outside being raucous and blocking the pavement; with passing trade also there are cars with sound systems parking on the double red lines and blocking the bus stop; reckless staff dumping rubbish after closing and making noise as they leave.

This kebab shop is directly opposite this premises and there would be a lot of inebriated shouting across the street as groups fail to disperse in the early hours from recklessly licensed premises with entertainment.

This kebab shop is situated directly adjacent to a bus stop so people hanging around outside would block the pavement or strung along a kebab alley.

One of the most difficult nuisances is additional litter and more of the noisy, costly, machine-led street cleaning in the early hours of the morning.

The locality is poorly served by LBH especially at the hours that have been applied for. With no licensing enforcement team or any other responsible authority pro-active at these hours the licensing objectives are consistently undermined by unsupervised premises and this application if not refused would add to the cumulative impact of nuisance and crime from similar premises and others in the immediate vicinity.

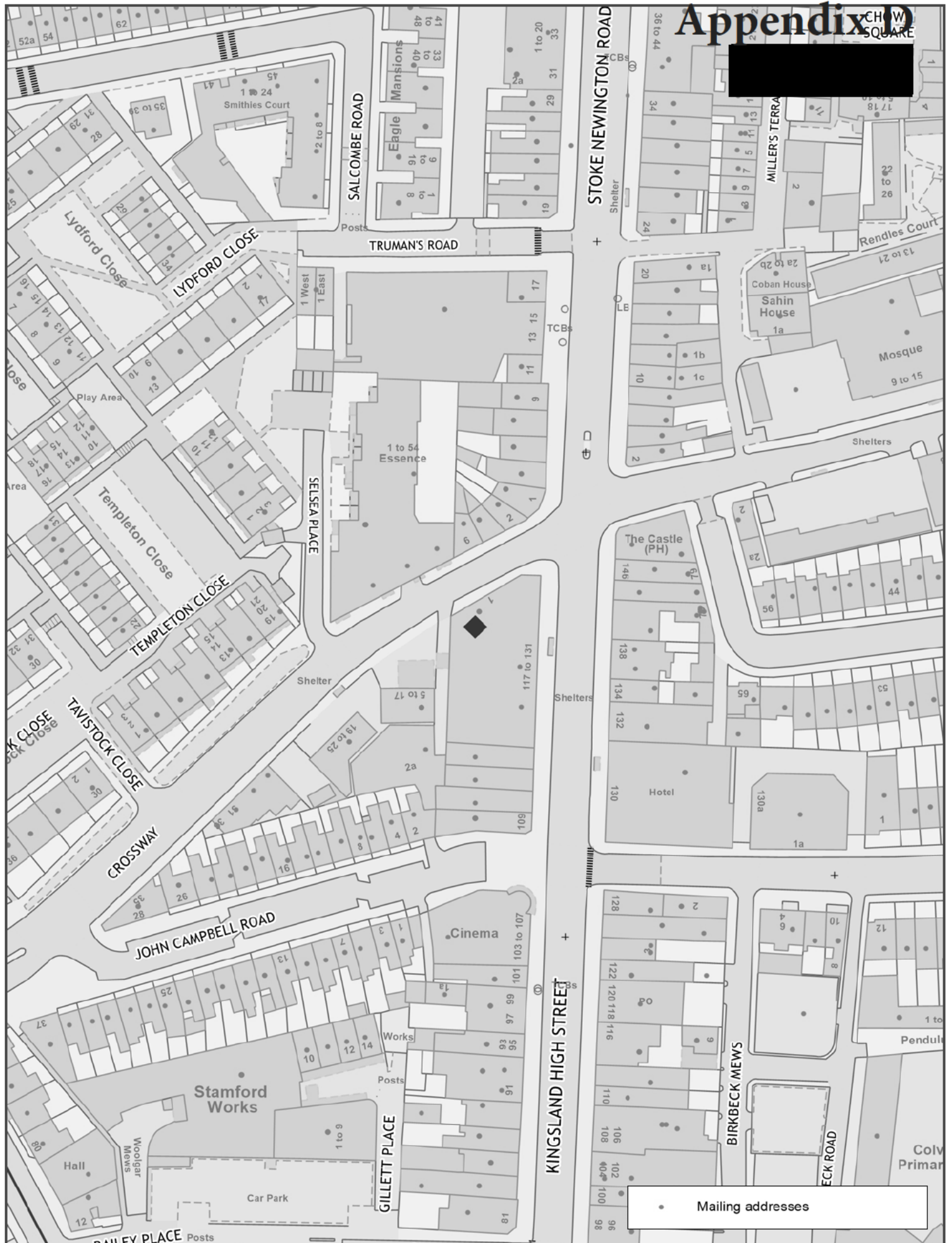
