### 1. Summary

1.1. This is an application to vary a premises licence to amend/replace existing licence conditions, to include recorded music and to extend terminal hours for the supply of alcohol for consumption on the premises on Monday to Sunday.

## 2. <u>Application</u>

- 2.1. Oskar Wojciech Klimaszewsk has made an application to vary a premises licence under section 34 of the Licensing Act 2003.
- 2.2. The applicant is seeking authorisation for the following proposed variation:
  - 1. To include recorded music
  - 2. To extend the terminal hours for supply of alcohol

3.To amend existing condition 8 of Annex 2 of the Premises Licence as follows: No drinks are to be taken outside the premises after 21:00 hrs.

4. To amend existing condition 9 of Annex 2 of the Premises Licence as follows: A sound limiting device shall be maintained to control all regulated entertainment generated in the premises so as to ensure noise nuisance is not caused in any residential premises. The device shall be approved by and set to the Council's satisfaction and thereafter maintained for the duration of its use. No additional noise generating equipment associated with regulated entertainment shall be used on the premises without being routed through a sound limiting device.

5.To replace existing 10 of Annex 2 of the Premises Licence with the following: All external windows and doors of the premises shall be kept closed from 21:00 hrs except for the immediate access and egress of patrons and staff

2.3. The application is attached as Appendix A.The applicant has proposed some additional measures to address the licensing objectives.

# 3. Current Status/History

- 3.1. The current premises licence was granted on 24 November 2005 (attached as Appendix D)
- 3.2. No Temporary Event Notices were submitted for the premises in the last 12 months.

## 6. **Guidance Considerations**

6.1. The Licensing Authority is required to have regard to any guidance issued by the Secretary of State under the Licensing Act 2003.

# 7. Policy Considerations

- 7.1. Licensing Sub-Committee is required to have regard to the London Borough of Hackney's Statement of Licensing Policy ("the Policy) adopted by the Licensing Authority.
- 7.2. The Policy applies to applications where relevant representations have been made. With regard to this application, policies, LP1 (General Principles), LP2 (Licensing Objectives) are relevant.

# 8. Officer Observations

8.1. If the Sub-Committee is minded to approve the application, the following amended conditions should be applied the licence:

1. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Hackney Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available upon the request of Police or authorised officer throughout the preceding 31 day period.

2. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.

3. On a yearly basis all staff shall be given refresher training on the legislation relating to sales of alcohol to underage persons, drunken persons and how to deal with people incapacitated by drink or drugs. Such training shall include first aid and any welfare training such as WAVE (or as amended). Records of the training to be kept at the venue and made available to police or authorised officers immediately upon request. Any new staff will be trained on appointment.

4. The sale of alcohol for consumption off the premises shall be in sealed containers until 23:00 only.

5. The licensee shall display the email address of the Designated Premises Supervisor for use by any Responsible Authority or any person who may wish to make a complaint during the operation of the licence in a prominent external location at the premises that is easily accessible to the public.

6. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police, which will record the following: a. all crimes reported to the venue; b. all ejections of patrons; c. any complaints received concerning crime and disorder; d. any incidents of disorder; e. all seizures of drugs or offensive weapons; f. any faults in the CCTV system or searching equipment or scanning equipment; g. any refusal of the sale of alcohol; and h. any visit by a relevant authority or emergency service.

7. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.

8. No deliveries to the premises shall take place between 23.00 and 08.00 on the following day.

9. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.

10. The Licensee shall ensure that all relevant staff are fully trained and made aware of the legal requirement of businesses to comply with their responsibility as regards the disposal of waste produced from the business premises. The procedure for handling and preparing for disposal of the waste shall be in writing where it can be referred to at all times by staff.

11. The Licensee shall ensure that any contract for general and recyclable waste disposal shall be appropriate in size to the amount of waste produced by the business. The Licensee shall. maintain an adequate supply of waste receptacles provided by his registered waste carrier (refuse sacks or commercial waste bins) in order to ensure all refuse emanating from the business is always presented for collection by his waste carrier and shall not use any plain black or unidentifiable refuse sacks or any other unidentifiable or unmarked waste receptacles.

12. In order to minimise the amount of time any waste remains on the public highway in readiness for collection, the Licensee will ensure the timeframe within which it may

expect its waste carrier to collect is adhered to.

13. The Licensee shall instruct members of staff to make regular checks of the area immediately outside the premises and remove any litter, bottles and glasses emanating from the premises. A final check should be made at close of business.

14. The Licensee shall provide a safe receptacle for cigarette ends to be placed outside for the use of customers, such receptacle being carefully placed so as not to cause an obstruction or trip.

15. The current trade waste agreement/duty of care waste transfer document shall be maintained in the premises where it can be conveniently seen and read by persons. This should remain available at all times and should clearly identify:-

- a. the name of the registered waste carrier
- b. the date of commencement of trade waste contract
- c. the date of expiry of trade waste contract
- d. the days and times of collection
- e. the type of waste including the European Waste Code

### 9. **Reasons for Officer Observations**

9.1. The above amended conditions (1 - 15) have been proposed by the applicant.

### 10. Legal Comments

- 10.1. The Council has a duty as a Licensing Authority under the Licensing Act 2003 to carry out its functions with a view to promoting the following 4 licensing objectives;
  - The Prevention of Crime and Disorder
  - Public Safety
  - Prevention of Public Nuisance
  - The Protection of Children from Harm

10.2. It should be noted that each of the licensing objectives have equal importance and are the only grounds upon which a relevant representation can be made and for which an application can be refused or terms and conditions attached to a licence.

# 11. Human Rights Act 1998 Implications

- 11.1. There are implications to;
  - Article 6 Right to a fair hearing
  - Article 14 Not to discriminate
  - Balancing: Article 1- Peaceful enjoyment of their possession (i.e. a licence is defined as being a possession) with Article 8 Right of Privacy (i.e. respect private & family life) to achieve a proportionate decision having regard to the protection of an individuals rights

against the interests of the community at large.

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

  - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or

wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.

- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from:
     (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of
     (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed

The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available upon the request of Police or authorised officer throughout the preceding 31 day period.
- 2. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 3. On a yearly basis all staff shall be given refresher training on the legislation relating to sales of alcohol to underage persons, drunken persons and how to deal with people incapacitated by drink or drugs. Such training shall include first aid and any welfare training such as WAVE (or as amended). Records of the training to be kept at the venue and made available to police or authorised officer immediately upon request. Any new staff will be trained on appointment.
- 4. The sale of alcohol for consumption off the premises shall be in sealed containers until 23:00 only.
- 5. The licensee shall display the email address of the Designated Premises Supervisor for use by any Responsible Authority or any person who may wish to make a complaint during the operation of the licence in a prominent external location at the premises that is easily accessible to the public.
- 6. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police, which will record the following:
  - a. all crimes reported to the venue;
  - b. all ejections of patrons;
  - c. any complaints received concerning crime and disorder;
  - d. any incidents of disorder;
  - e. all seizures of drugs or offensive weapons;
  - f. any faults in the CCTV system or searching equipment or scanning equipment;
  - g. any refusal of the sale of alcohol; and
  - h. any visit by a relevant authority or emergency service.
- 7. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 8. No deliveries to the premises shall take place between 23.00 and 08.00 on the following day.
- 9. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.

- 10. The Licensee shall ensure that all relevant staff are fully trained and made aware of the legal requirement of businesses to comply with their responsibility as regards the disposal of waste produced from the business premises. The procedure for handling and preparing for disposal of the waste shall be in writing where it can be referred to at all times by staff.
- 11. The Licensee shall ensure that any contract for general and recyclable waste disposal shall be appropriate in size to the amount of waste produced by the business. The Licensee shall. maintain an adequate supply of waste receptacles provided by his registered waste carrier (refuse sacks or commercial waste bins) in order to ensure all refuse emanating from the business is always presented for collection by his waste carrier and shall not use any plain black or unidentifiable refuse sacks or any other unidentifiable or unmarked waste receptacles.

The Licensing Authority has considered the application and submits the following comments.

The applicant is seeking to extend the hours for licensable activity by 1 hour on the following days, Thursdays, Fridays and Saturdays. Whilst the proposed extension for Friday and Saturday falls within LP3 Core Hours, the extension sought on Thursday goes beyond the current licensing policy.

#### LP3 Core Hours

*Hours for licensable activity will generally be authorised, subject to demonstrating LP1 and LP2, as follows:* 

• Monday to Thursday 08:00 to 23:00

• Friday and Saturday 08:00 to 00:00

• Sunday 10:00 to 22:30

Hours may be more restrictive dependent on the character of the area and if the individual circumstances require it.

Later hours may be considered where the applicant has identified any risk that may undermine the promotion of the licensing objectives and has put in place robust measures to mitigate those risks.

It should be noted that this policy does not apply to those who are making an application within a special policy area (see section 3) unless they have been able to demonstrate that the proposed activity or operation of the premises will not add to the cumulative impact that is already being experienced.

It should also be noted that where a premises is not in possession of planning permission for the proposed activity and/or hours may be further restricted during weekdays and not permitted at all at weekends.

Condition 4 of the proposed conditions attached to the application states the following;

We have been here since 1970


And we are have our quality of life eradicated, as disabled people we suffer from parking issues

#### Dear Councillors,

I am writing to object in the strongest possible manner to the proposal to extend the license at Home, 5a Ravey Street, Hackney, London, EC2A 4QW.

#### SPA context:

This location is right next to the Griffin Pub & three blind mice, which are all located in a part of Leonard/Ravey street and no more than a few hundred yards from Book Club on Leonard Street. Residents, supported by our ward councillors, have submitted evidence numerous times over the years to confirm the huge negative impact these licensed premises have had in this quiet area of Shoreditch. Councillor Plouviez was previosuly aware of submitted examples, and Councillor Sellman committed to Feryal and residents that the SPA boundary would be reassessed due to the fast-developing nature of our streets. This was never progressed to my knowledge, but must immediately be brough back to front of mind.

In addition to the large/established venues - there has recently the expansion of tacky, cheap booze venues and even "restaurant" are now contributing to all day drunkenness, due to the "bottomless brunch" trend.

Local services including Environmental noise team; local police; the "out of hours" incident reporting website are already unable to prevent the negative impacts on residents, and neighbouring properties.

#### Licencing context:

The license application to extend the supply of alcohol and play music until 00:00, Thursdays, Fridays and Saturdays is absolutely incredulous !!!!! Home bar is located directly **setup** he bedroom window of **setup** eonard street and only one storey further below to the bedroom of the two bedroom resident flat of **setup** eonard street. The back window disperses noise onto the back of numerous residential properties on Leonard and Willow Street. What on earth is Oskar thinking, these properties are at breaking point already with noise, disruption, drunken harassment, to extend this further into the night shows a total lack of human appreciation! This request must be rejected on the grounds of the high risk of adding to existing cumulative negative impact including:

- Public health and safety: drinkers exiting the venue until the early hours of the morning staggering into the road and urinating and or generally defacing private property all across Leonard & Ravey Street.
- Public nuisance: littering, noise nuisance from drivers parking under residential windows, at all hours; loud music (from car stereos, and outdoor drinking venues); drunk and shouty groups, including young girls vomiting on private property at 3-4pm (not just 3-4am) as is currently the case!
- Crime and disorder: pre-loading, and drug taking in the street, before going to clubs; dangerous driving; and violent behaviour.

In addition, existing venues in this exact part of Shoreditch already have licensing conditions which this would challenge or exacerbate the issue of their already poor compliance to.

Dipesh Confectioners – next door to 85 Leonard Street (Passione Vino) has a license for off-sales only, which requires them to close earlier than 22:30 to comply with.

The Griffin has a condition that no people should be outside drinking on the Leonard Street pavement, on the same side of the road as Passione Vino right from 91 to 75 Leonard Street and must close strictly at 11.30pm.

This section of Leonard street, next to Ravey Street and adjoining Great Eastern street is the most saturated part of the Shoreditch area, outside of SPA. It would be totally nonsensical and unbearable for local residents to allow an extension to a license to attract and empty further inebriated customers onto this part of Shoreditch. It will have a dramatic cumulative impact that cannot be ignored.

#### "Future Shoreditch" context:

We are in an area that is strategically planned to undergo intensive COMMERCIAL development and provide economic growth for the Borough and London. Several sites, in the Conservation Area, are already highlighted for demolition and newbuild office construction. Very few sites are as closely surrounded by residential properties as in Leonard Street.

Many developers and businesses in this area are driven by profit, profit which comes from Alcohol sales.

The real cost- the impact on the Local community, residents, and public resources - is unsustainably high.

Granting further licensing and negligently allowing venues to attract and empty further customers onto this saturated part of Leonard Street would be catastrophic in destroying trust in the council to effectively manage the area and licensed premises.

Please ensure that this Licence application is rejected.

1. No supply of alcohol may be made under the premises licence:

(a) At a time when there is no designated premises supervisor in respect of the premises licence.

(b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- 4. dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on

request to customers where it is reasonably available.

6. 5.1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sales or supply of alcohol.

5.2 The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

5.3. The policy must require individuals who appear to the responsible person to be under 18 years if age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-

- A. a holographic mark or
- B. an ultraviolet feature.
- 7. The responsible person shall ensure that:

a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:

- beer or cider:1/2 pint;
- gin, rum, vodka or whisky: 25ml or 35ml; and
- still wine in a glass: 125ml; and
  - a. these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - b. where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

### Minimum Drinks Pricing

7.1 A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

7.2 For the purposes of the condition set out in paragraph 7.1 above -(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula - P = D+(DxV)Where -

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(c) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(d) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence; (e) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(f) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

7.3 Where the permitted price given by Paragraph 8.2(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

7.4 (1) Sub-paragraph 7.4(2) below applies where the permitted price given by Paragraph 7.2(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

## Annex 2 – Conditions consistent with the Operating Schedule

- 8. No drinks are to be taken outside the premises.
- 9. Sound limiting device(s) (device type to be approved by the Council's pollution team) are to be installed to all music systems. The limiting device(s) should be set to ensure in audibility in all nearby residential premises and a certificate of compliance should be submitted to the Council's Pollution Team. The device should be controlled by the licensee and kept in a locked, tamper-proof box.
- 10. The doors a t the front of the premises are to be kept closed except for access to and egress from the premises, and shall be connected to the sound limiter so that the level of the background music will be reduced if the door remains open beyond a period of time to b e agreed with the Council's pollution team.
- 11. Notices are to be displayed in prominent locations within the premises advising customers to leave (and whilst outside the premises to act) in a quiet and orderly manner so as not to disturb the occupiers of the adjoining premises.
- 12. Notices are to be displayed in prominent locations within the premises advising customers that no drinks are to be taken outside the premises.
- 13. All windows at the premises are to be kept closed.
